

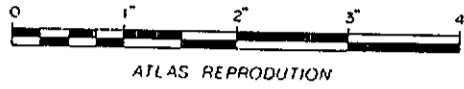

SCALE 1" = 50 FEET

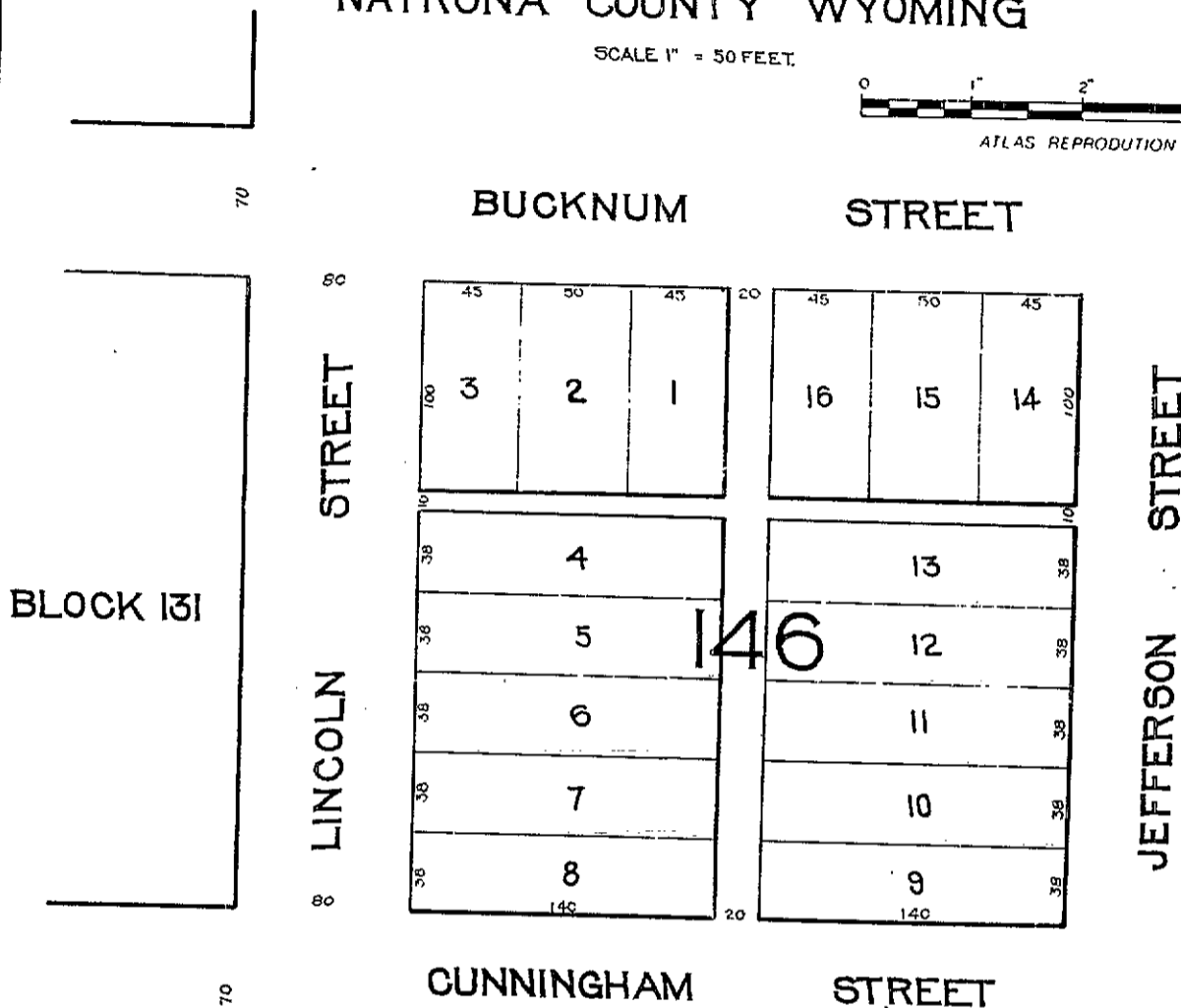

Robins, a single man, do hereby certify that I am the sole owner of Block 146, City of Casper, situated in and being a part of the NW 1/4 of the NW 1/4 of Section 10, Township 33 North, Range 79 West 6 R.M. in the County of Natrona, State of Wyoming, and further described as follows: - beginning at a point 60 feet due east of the southeast corner of Block 131 in the Town of Casper; thence due east, along the north line of Cunningham Street produced, 300 feet; thence due north, along the west line of Jefferson Street produced, 300 feet; thence due west, along the south line of Bucknum Street produced, 300 feet; thence due south, along the east line of Lincoln Street produced, 300 feet, to the point of beginning, that the resubdivision of said Block 146 as the same appears upon this plat is with my free consent and in accordance with my desires, and that said resubdivision shall be known as "Resubdivision of Block 146, City of Casper, Natrona County, Wyoming."
