

CERTIFICATE OF DEDICATION

THE CITY OF CASPER, Natrona County, Wyoming hereby certifies that it is the owner and proprietor of the foregoing area consisting of a portion of the NW 1/4 of Section 35, T.34N., R.79W., 6th P.M., Natrona County, Wyoming, and that this plat is in accordance with the desires and is with free consent of the undersigned owner and proprietor of said lands which are more particularly described by metes and bounds as follows:

The point of beginning is marked by a brass cap set at the NW corner of said area and lies S.01°26'17"W. 412.53 feet from the NW corner of said Section 35.

From said point of beginning, proceed S.01°26'17"W. along the west line of said Section 35 a distance of 899.67 feet to a brass cap marking the NW corner common to Section 34 and said Section 35; thence continuing S.01°27'02"W. along the west line of said Section 35 a distance of 990.00 feet to the SW corner of said area, referenced by a witness corner set N.82°46'32"E. 40.00 feet; thence N.82°46'39"E. a distance of 2660.48 feet to a point on the N-S centerline of said Section 35 and a brass cap marking the SE corner of said area; thence N.01°42'30"E. a distance of 660.00 feet to a brass cap marking the NW corner of said Section 35; thence continuing N.01°42'30"E. along the N-S centerline of said Section 35 a distance of 900.00 feet to a brass cap marking the NE corner of said area; thence S.89°53'27"W. a distance of 2638.22 feet to the point of beginning.

All lands in the foregoing area as previously described by metes and bounds and as set forth on this Platting, contain 104.27 acres, more or less, and as appears on this Plat is with the free consent and in accordance with the desires of THE CITY OF CASPER, the owner and proprietor of said lands, subject to easements as shown on this plat.

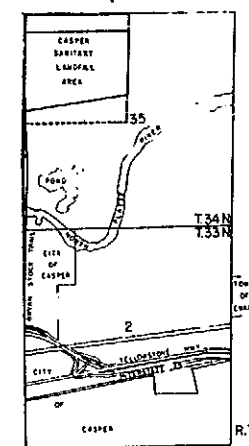
