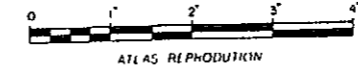

CERTIFICATE OF PLATTING

This is to certify that the addition shown on the annexed plat is to be known as "C & NW ADDITION NO. 3" and more particularly described as follows:

A Parcel located in and being a portion of the N½ NE¼, Section 9, Township 33 North, Range 79 West of the 6th Principal Meridian, Natrona County, Wyoming, Beginning at a point which marks the intersection of the westerly line of South Durbin Street with the northwesterly line of East Railroad Avenue, City of Casper, Natrona County, Wyoming, which point is also the southwest corner of the Parcel being described; thence from said point of beginning, North along the easterly line of said Durbin Street, 156.78 feet to the northwesterly corner of said Parcel and the southwest corner of the "Casper Service and Supply Tract"; thence along the southerly line of said tract and the northerly line of the Parcel being described, N 66° 18' E, 207.40 feet to a point; thence N 25° 44' E, 43.86 feet to a point on the easterly line of said "Casper Service and Supply Company Tract", thence leaving said Tract line, S 25° 56' E, 160.13 feet to a point on the northwesterly line of East Railroad Avenue, City of Casper, thence S 64° 05' W, along the northwesterly line of said Avenue, 310.24 feet to the point of beginning. The foregoing described Parcel containing 38,265 square feet, (0.878 Acres)

is made with the free consent and in accordance with the desires of the undersigned owners and proprietors, waiving and relinquishing all rights in said lands which they may have under and by virtue of the exemption laws of the State of Wyoming

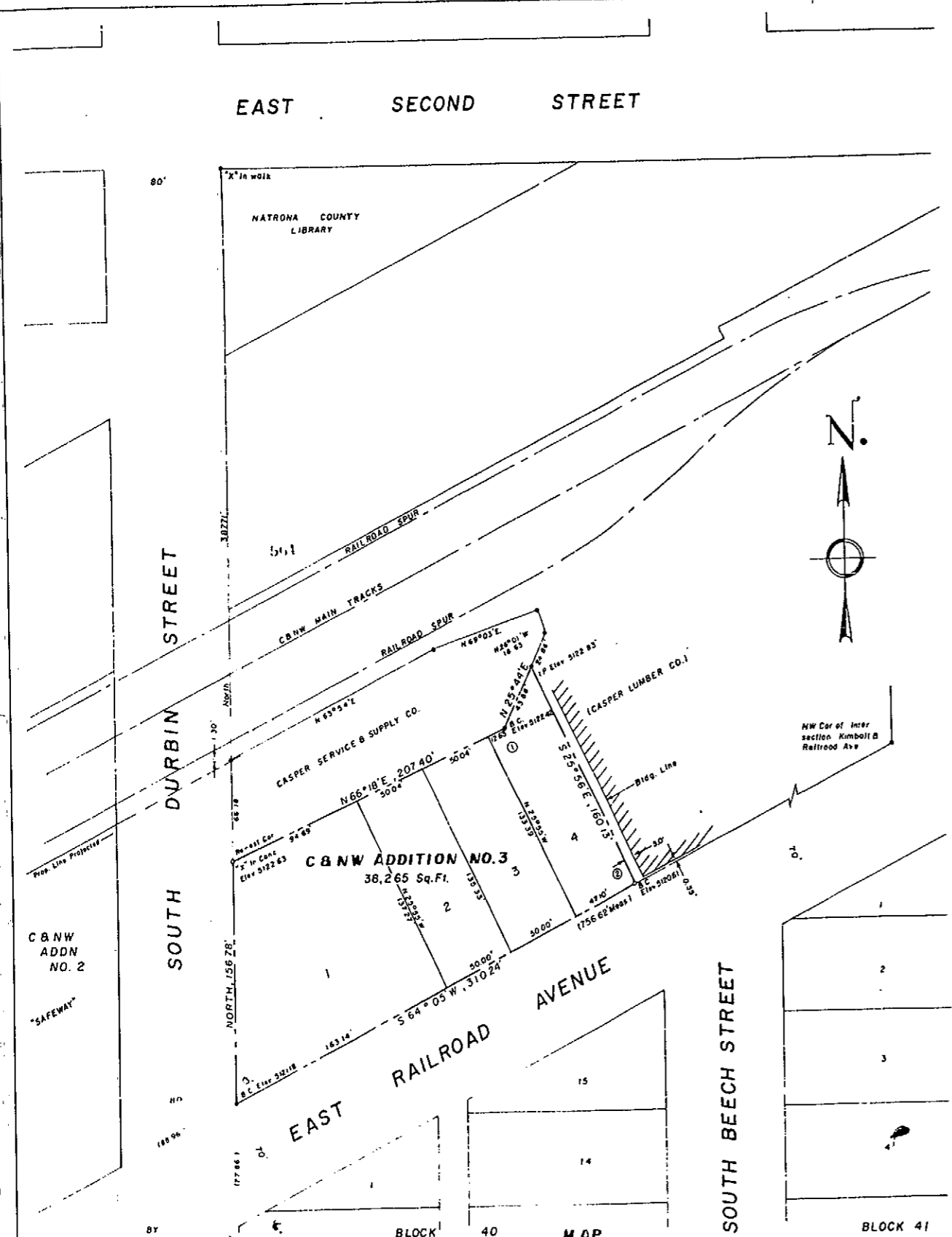
