

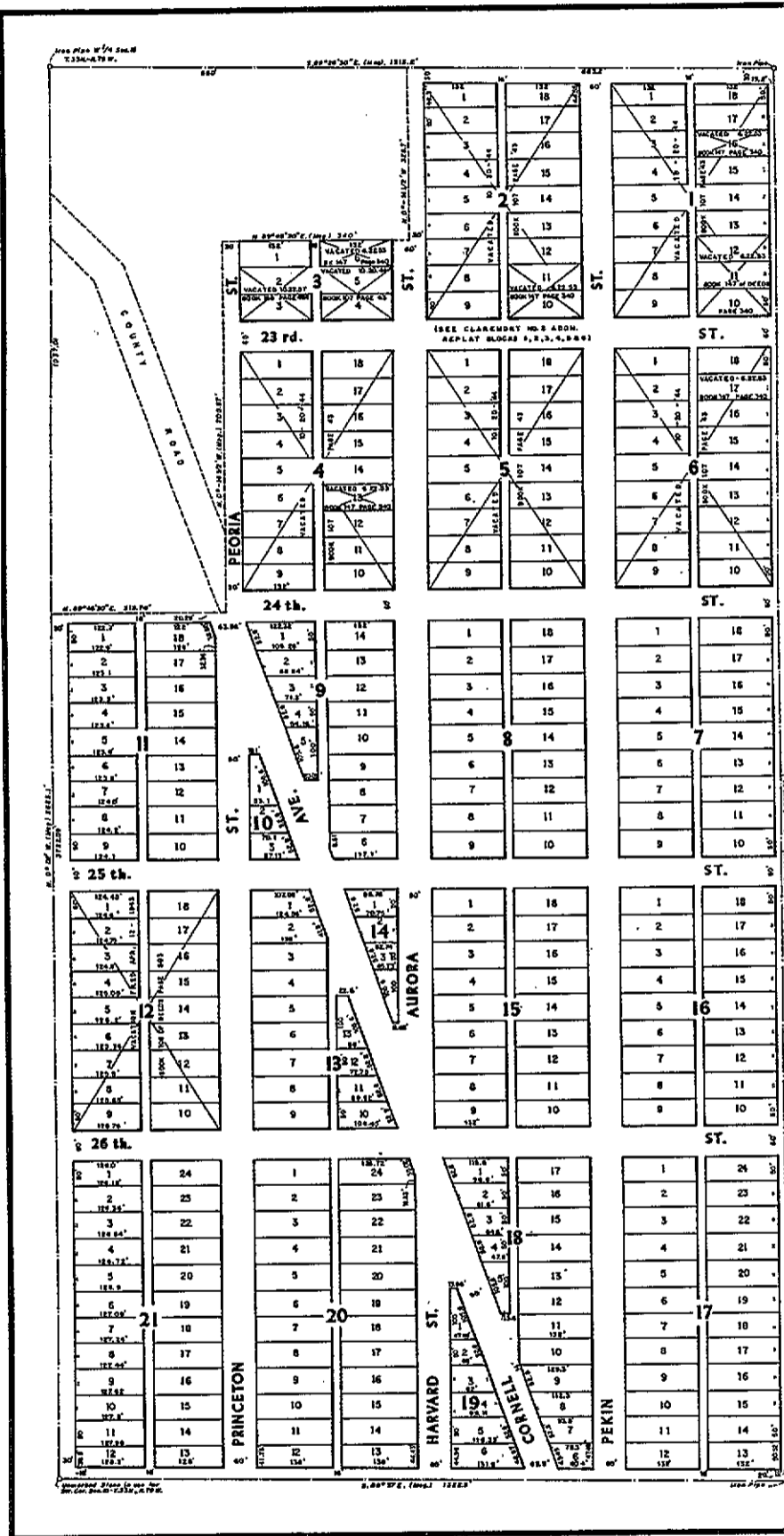

On this 24th day of June, A.D. 1921, before me personally appeared Albert Park, of lawful age and to me personally known, who being by me first duly sworn, did depose and say and certify as follows to wit:
 That said Albert Park is and was during all times herein set forth a civil engineer duly licensed as such under the laws of the State of Wyoming; that the foregoing map, plat and subdivision was made with reference to known monuments by getting and indicating the dimensions and length and breadth of the subdivision and the breadth and courses of all the streets and alleys established in said subdivision from notes taken during an actual survey made by me on May 30, 1921, and at the request of The Van Gorden Investment Company, a corporation duly organized and existing under and by virtue of the laws of the State of Wyoming and that said map and plat correctly represents and accurately describes the said subdivision of a portion of the West One Half (W1/2) of the Southwest One Quarter (SW1/4) of Section Fifteen (15), Township Thirty-three (33) North, Range Seventy-nine (79) West of the Sixth Principal Meridian, said subdivision to be known as the "COUNTRY CLUB ADDITION, TO THE CITY OF CASPER, NATRONA COUNTY, STATE OF WYOMING," into blocks, lots, streets and alleys as actually stated on the ground together with lines as follows: To unmarked stone in use for the SW corner of said section having been used as such for the platting of Alameda Addition and for the Thordale Acres, by Wheeler B. Worthington; to iron pipe established at the W1/4 corner of said section by Frank Kettle City Engineer and to iron pipe at SE corner of W2 SW4 of said section in use before and checked by me also to iron pipe established by me for the NE corner of the W2 SW4 of said section.
