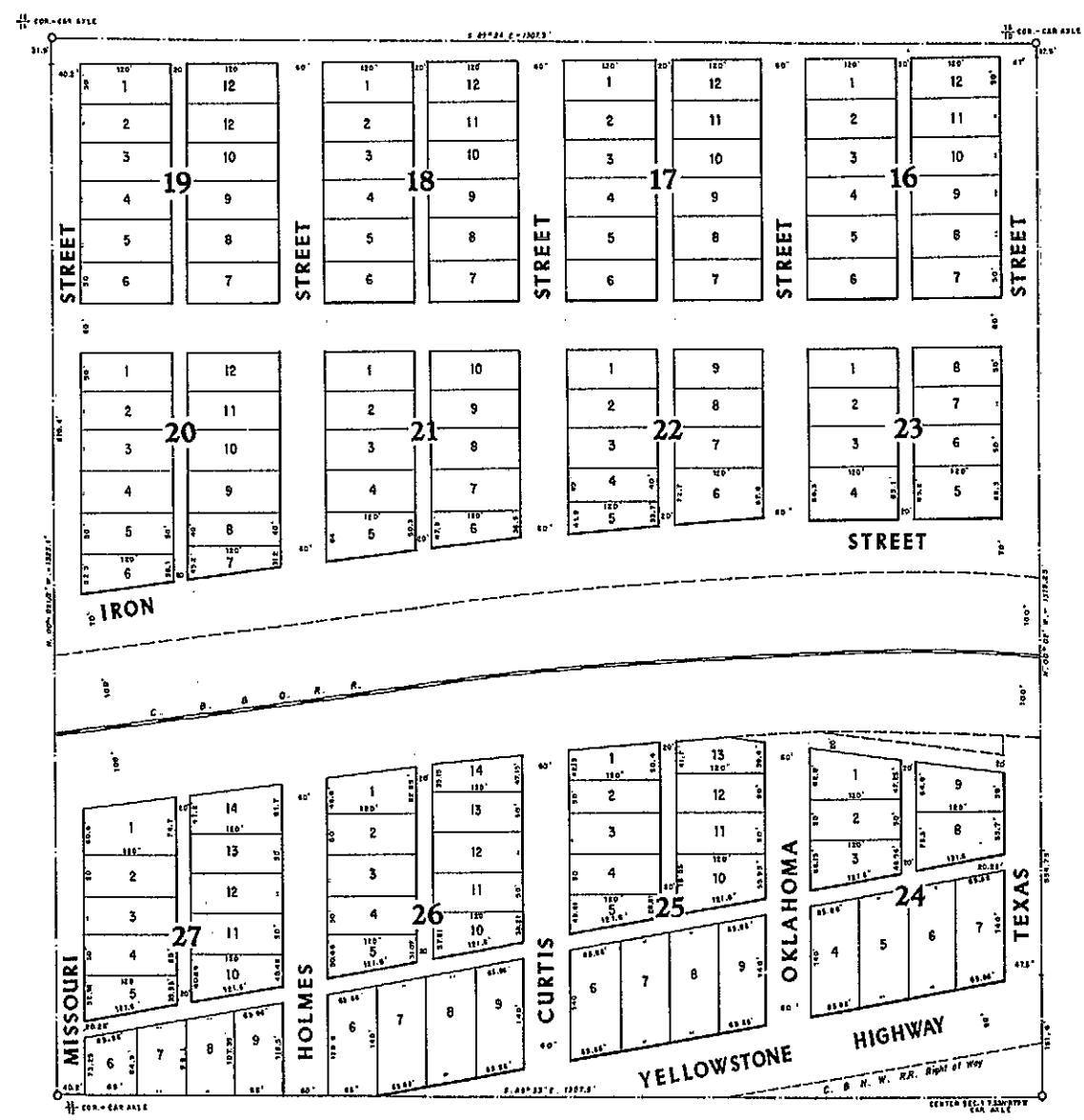

This to certify that the survey and subdivision of "Evansville Addition" as drawn hereon and comprising the Southeast Quarter of the Northwest Quarter (SE4NW4) of Section One (1), Township Thirty-Three (33) North, Range Seventy-Nine (79) West of the Sixth Principal Meridian was made by me during the month of August, A.D. 1922, at the request of and for Harvey Hess. The survey was executed with a Gurley transit and a 300 ft. Steel tape. Each block corner is marked with a 4"x4"x30" Pine post set 20" in the ground, tacked and painted white. The ends of the alleys in each block are marked with a 3"x3"x24" pine post set 20" in the ground and painted white. Each lot corner facing a street is marked with a 2"x2"x16" pine stake driven 12" in the ground and painted white. The block numbers were painted in black on the block corners and the lot numbers on the lot stakes. The section and quarter corners used were the same used previously in platting "EVANSVILLE" and the 1/16 corners were determined according to the prescribed rules of the U.S. Land Office. All angles and linear measurements were made with care and to the best of my knowledge and belief are correct within reasonable limits of error.
