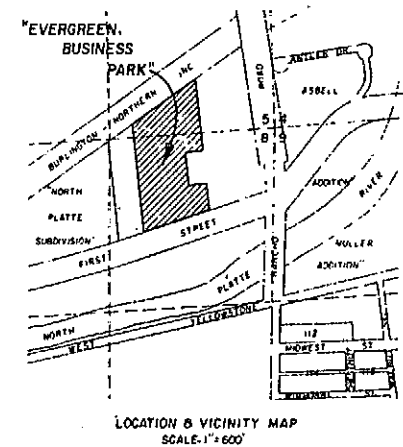
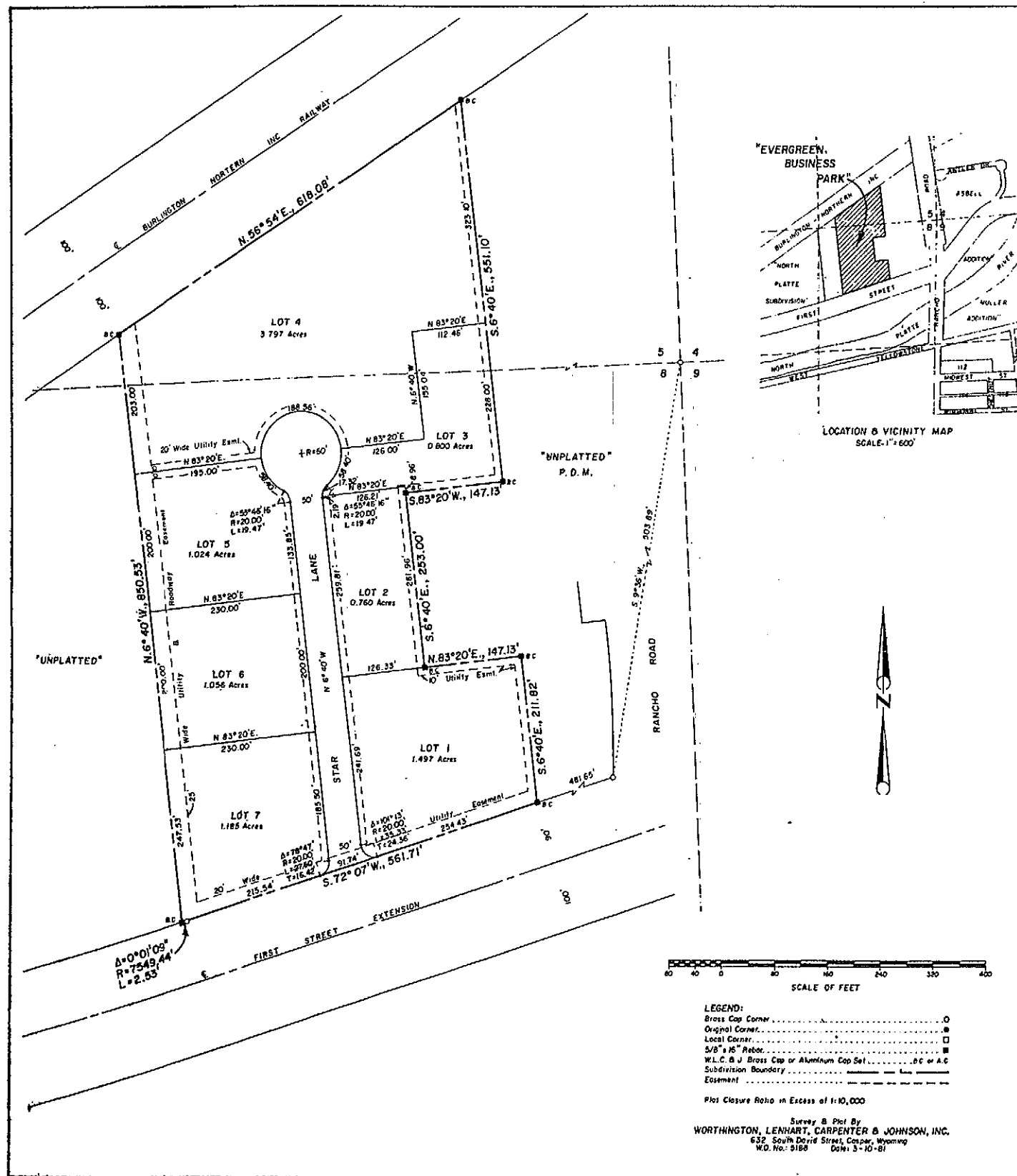

 CERTIFICATE OF DEDICATION

Richard P. Greiner, an individual, and Jeffrey G. Jones, an individual,  
 Hereby certify that they are the owners and proprietors of the foregoing subdivision located in and being portions of the SE1/4 SE1/4, Section 5 and the NE1/4 NE1/4, Section 8, Township 33 North, Range 79 West of the Sixth Principal Meridian, Natrona County, Wyoming and being more particularly described by metes and bounds as follows:

Commencing at the section corner common to Sections 4, 5, 8 and 9 of said Township, thence, S 9°35' W, 503.89 feet to a point and intersection with the westerly line of 150 feet wide Raucha Road and the westerly line of 100 feet wide First Street, thence along the northerly line of said First Street, S 72°07' W, 481.65 feet to the southeasterly corner of the Parcel being described and the Point of Beginning; thence from said Point of Beginning and along the southerly line of said Parcel and northerly line of said First Street, S 72°07' W, 561.71 feet to a point of curve, thence along the arc of a true curve to the right, having a radius of 7549.44 feet and through a central angle of 0°01'09", westerly 2.53 feet to the southeasterly corner of said Parcel, thence along the westerly line of said Parcel, N 6°40' W, 850.33 feet to the northeasterly corner of said Parcel and a point in the southerly right-of-way line of Burlington-Northern Inc., thence along the northerly line of said Parcel and southerly line of said right-of-way, N 56°54' E, 618.08 feet to the northeasterly corner of said Parcel, thence along the easterly line of said Parcel, S 6°40' E, 551.10 feet to a point, thence, S 83°20' W, 147.13 feet to a point, thence, S 6°40' E, 753.00 feet to a point, thence, N 83°20' E, 147.13 feet to a point, thence continuing along the easterly line of said Parcel, S 6°40' E, 211.82 feet to the Point of Beginning and containing 11.003 acres, more or less.

The subdivision of the foregoing described lands as appears on this Plat is with the free consent and in accordance with the desires of the undersigned owners and proprietors, the name of said subdivision shall be known as "EVERGREEN BUSINESS PARK", an Addition to the City of Casper, Wyoming, and all streets and public ways as set forth by this Plat are hereby dedicated to the use of the public.
