**CERTIFICATE OF DEDICATION**

Freda R. Lower and Dennis H. Lower, Trustees, or their Successors in Trust, under the Freda R. Lower Living Trust dated August 14, 1981 and any amendments thereto, hereby certify that they are the owners and proprietors of the foregoing vacation and replat of Lot 4, Block 5, Freden Addition, to the Town of Mills, Wyoming, a subdivision of a portion of the SW1/4NE1/4, Section 12, Township 33 North, Range 80 West of the Sixth Principal Meridian, Natrona County, Wyoming and being more particularly described by metes and bounds as follows:

Beginning at the southeastern corner of the Parcel being described and the northeastern corner of Lot 5, Freden Addition and a point in the westerly line of Chamberlin Road; thence along the southerly line of said Parcel and the northerly line of said Lot 5, Block 5, Freden Addition, S.89°30'43"W, 845.00 feet to the southwestern corner of said Parcel and the southerly corner of Lot 2, Block 5, Freden Addition; thence along the westerly line of said Parcel and the easterly line of said Lot 2, Block 5, Freden Addition, N.0°58'57"E, 253.09 feet to a point and northerly corner of said Lot 2, Block 5, Freden Addition; thence along the westerly line of said Parcel and the northerly line of said Lot 2, Block 5, Freden Addition, N.0°11'21"E, 134.86 feet to a point and northerly corner of said Lot 2, Block 5, Freden Addition; thence along the westerly line of said Parcel and the northerly line of said Lot 2, Block 5, Freden Addition, N.0°09'00"E, 253.09 feet to a point and northerly corner of said Parcel and the southerly line of said Lot 3, Block 5, Freden Addition and a point in and intersection with the westerly line of Chamberlin Road; thence along the easterly line of said Parcel and the westerly line of said Chamberlin Road, S.01°15'32"W, 389.77 feet to the Point of Beginning and containing 8.065 acres, more or less.

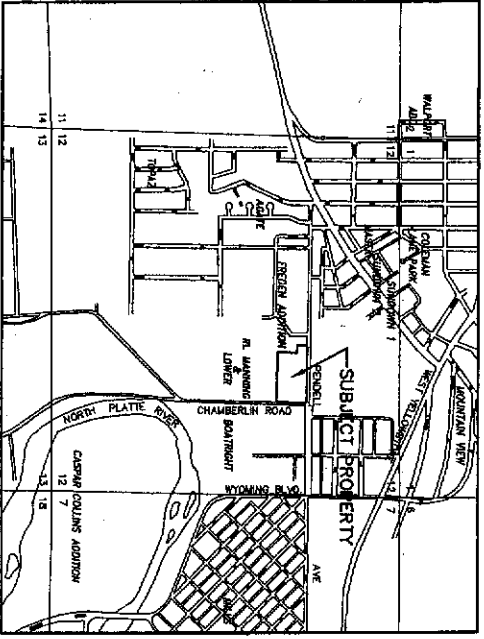
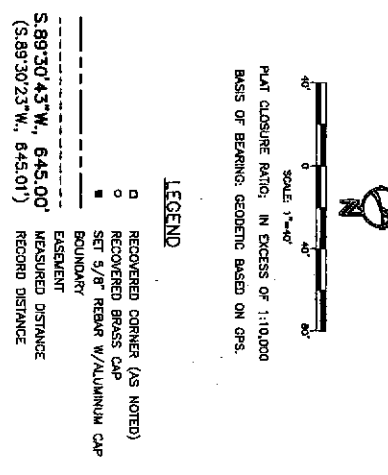
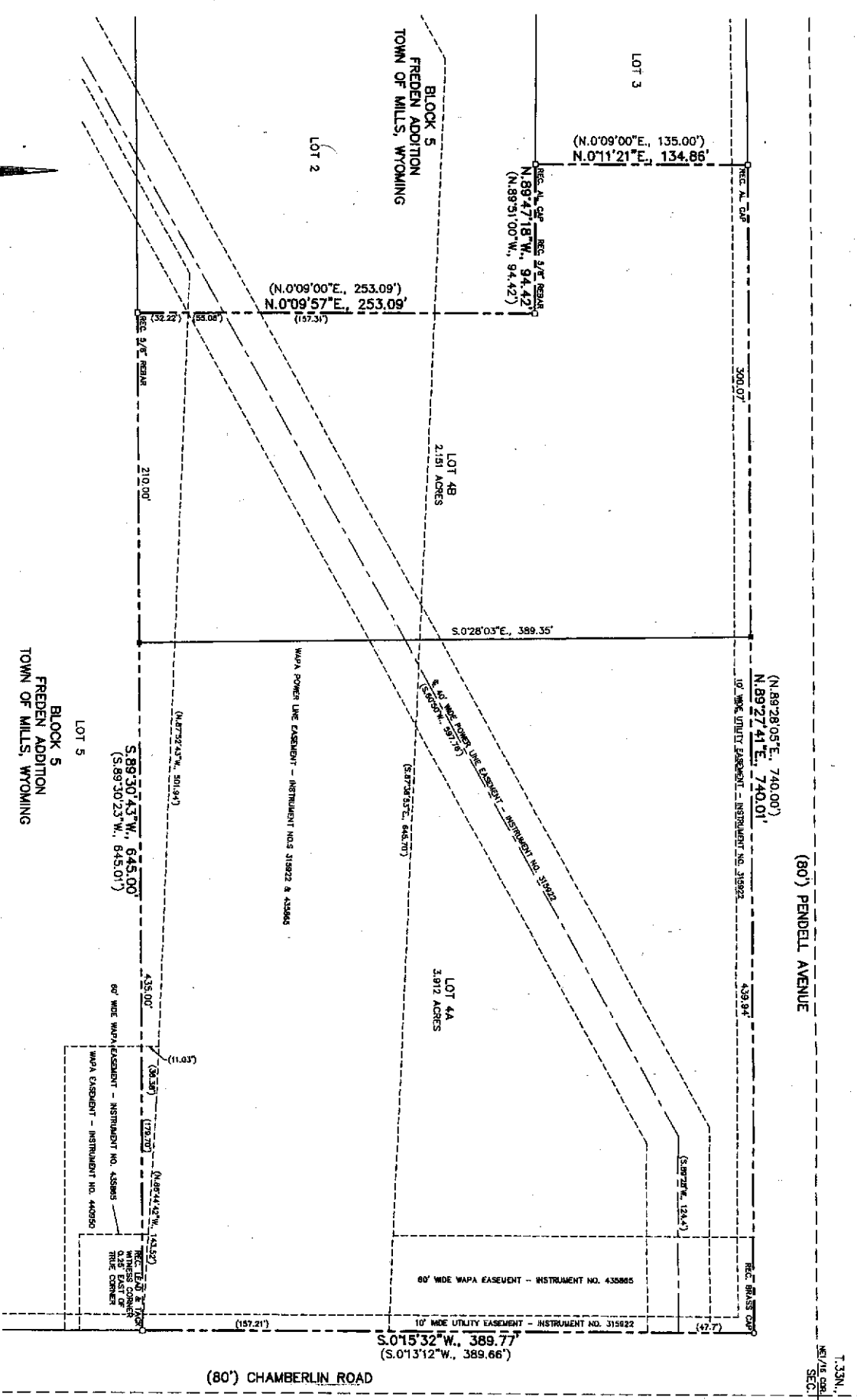
