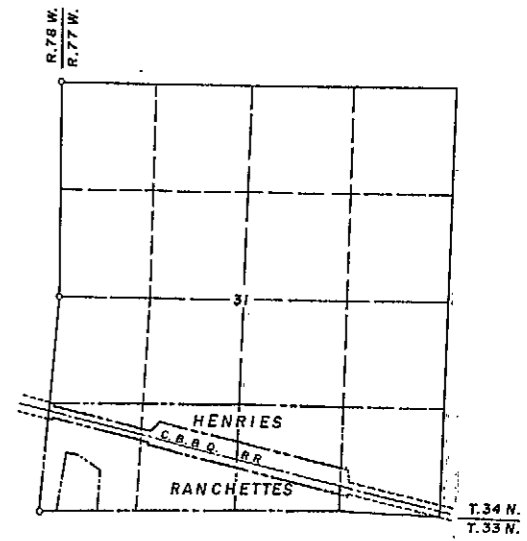
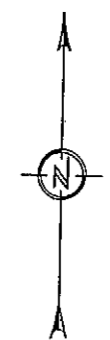
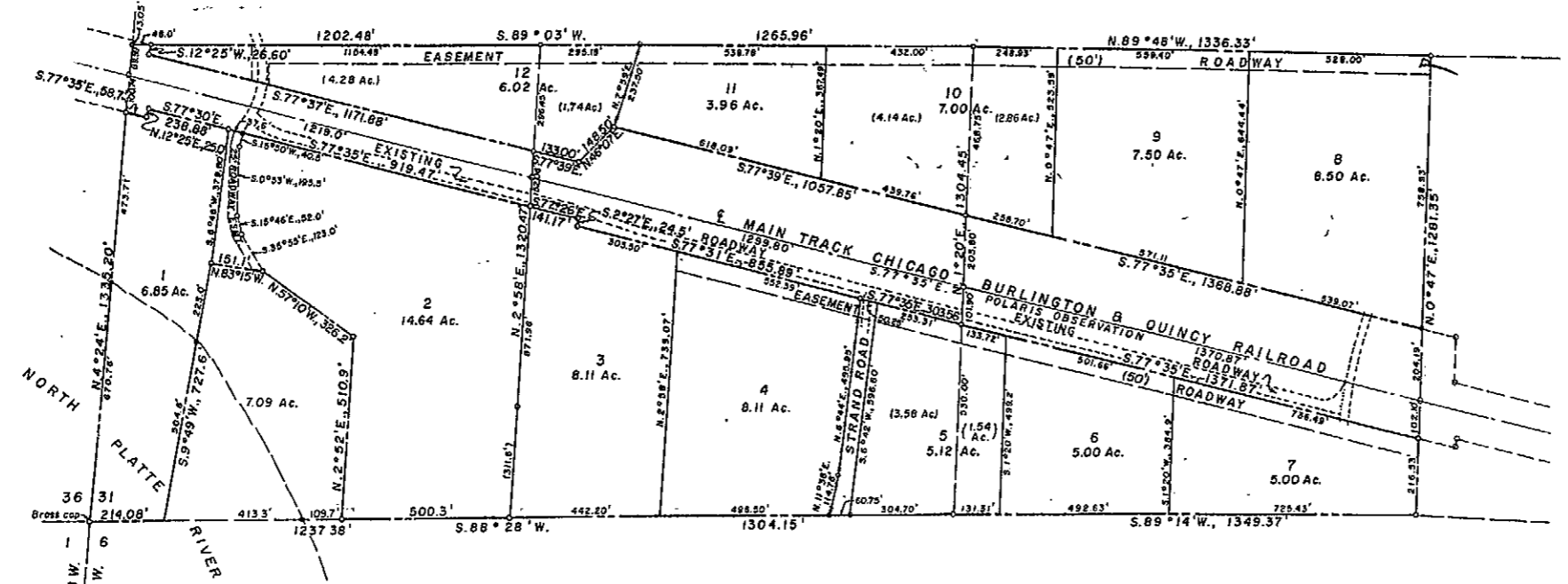

CERTIFICATE OF DEDICATION

Wayne L. Henrie and Barbara L. Henrie, husband and wife, hereby certify that they are the owners of the foregoing Subdivision of portions of the S½ SW¼ and SW¼ SE¼, Section 31, Township 34 North, Range 77 West of the 6th Principal Meridian, Natrona County, Wyoming and that this plat is with the free consent and desire of the undersigned owners and proprietors of said lands, the platted portions of which are more particularly set forth by metes and bounds description as follows:

Beginning at the southwest corner of Section 31 and S½ SW¼ thereof, said corner being marked by a U.S. Government Resurvey Brass cap; thence along the westerly line of said Section 31, N.4°24'E., 1335.20 feet to the northwest corner of said S½ SW¼, Section 31, thence along the north line of said S½ SW¼, Section 31, N.89°03'E., 2468.44 feet to the northeasterly corner thereof; thence along the north line of said SW¼ SE¼, Section 31, S.89°48'E., 1336.33 feet to the northeasterly corner thereof; thence along the easterly line of said SW¼ SE¼, Section 31, S.0°47'W., 1281.35 feet to the southeasterly corner thereof and a point in the southerly line of said Section 31; thence along the south line of said Section 31, S.89°14'W., 1349.37 feet to the southwest corner of said SW¼ SE¼; thence S.88°28'W., 1804.45 feet, along the south line of said S½ SW¼, Section 31, to a point and southeasterly corner of a previously conveyed 7.09 acre parcel; thence along the perimeter of said parcel, N.2°52'E., 510.9 feet to an angle point; thence N.57°10'W., 326.2 feet to a point; thence N.83°15'W., 151.1 feet to a point; thence along the westerly line of said parcel, S.9°49'W., 727.6 feet to the southwesterly corner of said parcel and a point in the southerly line of said S½ SW¼, Section 31; thence along the southerly line thereof S.88°28'W., 214.08 feet to the point of beginning and containing a total of 108.54 acres of which 22.02 acres are contained within the Right of Way lines of the Chicago, Burlington and Quincy Railroad Company as now fenced and more particularly set forth by this plat.
