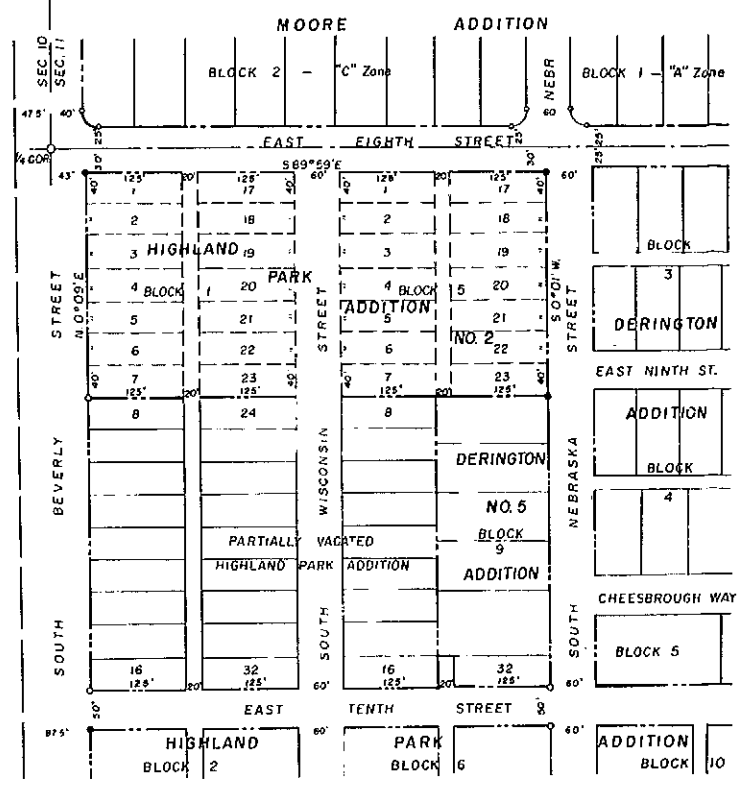
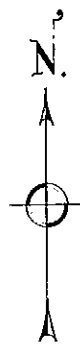


HIGHLAND PARK ADDITION NO. 2

CERTIFICATE OF DEDICATION

This is to certify that The Evangelical Lutheran Church, a non-profit Minnesota corporation, is the owner and proprietor of the above named subdivision as shown on the annexed plat and which subdivision consists of vacated Lots 1 through 7 inclusive and Lots 17 through 23 inclusive of both vacated Blocks 1 and 5 of Highland Park Addition to the City of Casper, Natrona County, Wyoming, and which subdivision includes that portion of the NW 1/4 NW 1/4 SW 1/4 of Section 11 in T. 33 N., R. 79 W. of the 6th P.M. more particularly described as follows:

Beginning at the Northwest corner of said vacated Lot 1 in said vacated Block 1 of Highland Park Addition to the City of Casper, Natrona County, Wyoming, as originally platted, which corner is located S 89° 59' E, 4300 feet and S 0° 09' W, 3000 feet from the Northwest corner of said SW 1/4, Section 11, thence from the point of beginning S 89° 59' E, 601.10 feet along the north line of said vacated Blocks 1 and 5, which line is also the south line of East Eighth Street, to the Northeast corner of said vacated Block 5, thence S 0° 09' W, 278.18 feet along the easterly line of said vacated Block 5 to the Southeast corner of said vacated Lot 23 of said vacated Block 5, said corner also being the Northeast corner of Derrington No. 5 Addition, Block 9 to said City of Casper, thence West along the northerly line of said Derrington Addition and the southerly line of said vacated Lots 23 and 7 of said vacated Block 5 and said vacated Lots 23 and 7 of said vacated Block 1, 601.90 feet to the southwest corner of said vacated Lot 7 in vacated Block 1, thence N 0° 09' E, along the westerly line of said vacated Block 1, 278.21 feet to the Northwest corner of said vacated Block 1 to the point of beginning. Said Parcel contains 3.842 acres.

Said subdivision includes Tracts A and B and is known as Highland Park Addition Number 2 to the City of Casper, Natrona County, Wyoming, and in accordance with the desire of the above named owner and proprietor, The Evangelical Lutheran Church, that portion of the street as shown on the annexed plat is dedicated to the public for public use.
