CERTIFICATE OF PLATTING
 IN ACCORDANCE WITH ORDINANCE No. 139, THE TOWN OF MILLS
 EFFECTIVE AS OF AUGUST 9, 1963.

The Town of Mills, Natrona County, Wyoming and the Mayor and Town Council thereof having on the 9 day of August, 1963 received a petition from all the owners of all the lands of that certain tract hereinafter particularly described to wit:

Tract, piece and parcel of real estate, lying and being in the NE 1/4 NE 1/4, Section 12, T.33 N., R.80 W. of the 6th Principal Meridian, Natrona County, Wyoming, being bounded on the south by Reclamation Center Addition, Blocks 1, 2, and 3; on the west by the west line of said NE 1/4 NE 1/4, Section 12; on the north by a part of the north line of said NE 1/4 NE 1/4, Section 12 and also the southerly Right of Way line of U.S. Highways No. 20 & 26, and on the east by the easterly line of said NE 1/4 NE 1/4, Section 12 and which said Tract is set out by the Official Plat of "Kiskis Subdivision" of the NE 1/4 NE 1/4, Section 12, T.33 N., R.80 W. of the 6th Principal Meridian, Natrona County, Wyoming and filed for record, in the office of the County Clerk and Ex-Officio Register of Deeds of Natrona County, Wyoming on the 2 day of February, 1948, and there recorded in Book 120 of Deeds of Page 572. Said Tract being set out as Blocks 3, 4, 5, 6, 7, and 8 of said Subdivision together with included Streets, Alleys and Public-ways is more particularly described as follows:

Beginning at the northeasterly corner of said Tract, which corner and point marks the northeasterly corner of said Block 7, "Kiskis Subdivision" and a point of intersection with the southerly Right of Way line of said U.S. Highways No. 20 and 26, and which point is located at S. 0° 18' W., 320.2 feet from the northeasterly corner of said NE 1/4 NE 1/4, Section 12; thence S. 0° 18' W., 642.6 feet along the easterly line of said NE 1/4 NE 1/4, Section 12 to the northeasterly corner of Block 1, Reclamation Center Addition; Thence due west along the north line of Block 1, 2, and 3 of said Reclamation Center Addition, 1265.38 feet to the northwest corner of said Block 3 and a point on the westerly line of said NE 1/4 NE 1/4, Section 12 and also "Kiskis Subdivision", said point being located at N. 0° 11' E., 361.4 feet from the southwesterly corner of said NE 1/4 NE 1/4, Section 12; Thence from the northwest corner of said Block 3 and along the westerly line of said NE 1/4 NE 1/4, Section 12, N. 0° 11' E., 949.95 feet to the northwesterly corner thereof and also said "Kiskis Subdivision"; Thence along the northerly line of said "Kiskis Subdivision" and also said NE 1/4 NE 1/4, Section 12, N. 89° 24' E., 565.13 feet to a point of intersection with the southerly Right of Way line of said U.S. Highways No. 20 & 26; Thence along said Highway Right of Way line, S. 65° 55' E., 767.81 feet to the point of beginning and containing 25.2 acres more or less;

To have the said tract included within the Corporate Limits of said Town of Mills and said Town Council having first published notice in accordance with Section 29-1205, Wyoming compiled Statutes of 1945, as amended by Chapter 130 Session Laws of 1947, and at a public hearing held pursuant to said notice, the said Town Council determined that said petition should be granted and that said tract should be included in and become a part of the Town of Mills, Wyoming and to be known and described as KISKIS ADDITION TO THE TOWN OF MILLS, NATRONA COUNTY, WYOMING. Wherefore in compliance with Ordinance No. 139 of the Town of Mills, the Town Council of said Town of Mills has caused the Corporate name of the said Town of Mills to be hereunto subscribed by its theraunto duly authorized Mayor, attested by its Town Clerk and has caused its Corporate Seal to be hereunto affixed this 6 day of MAY, 1964.

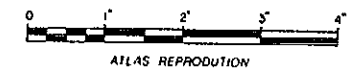
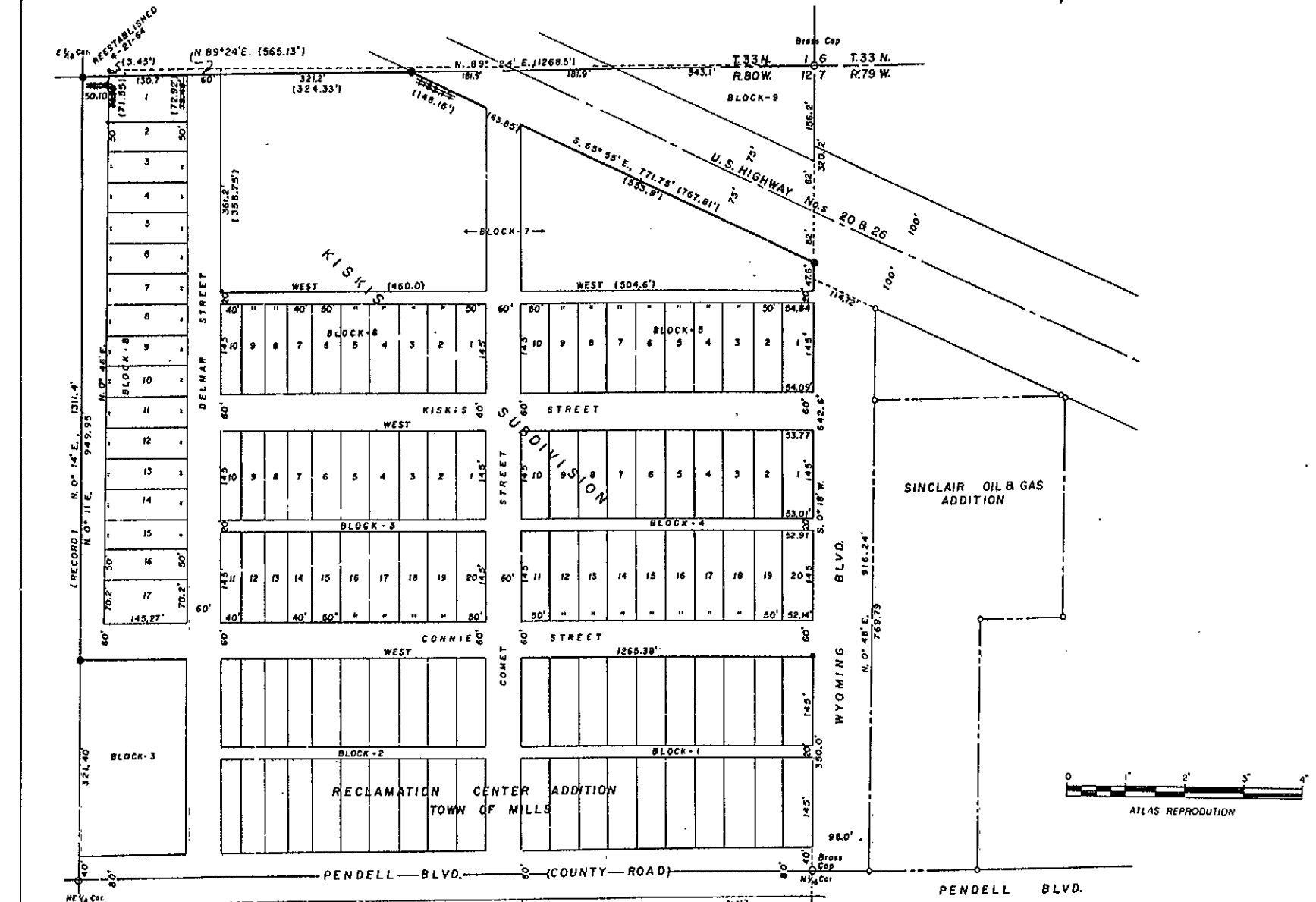

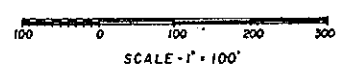
