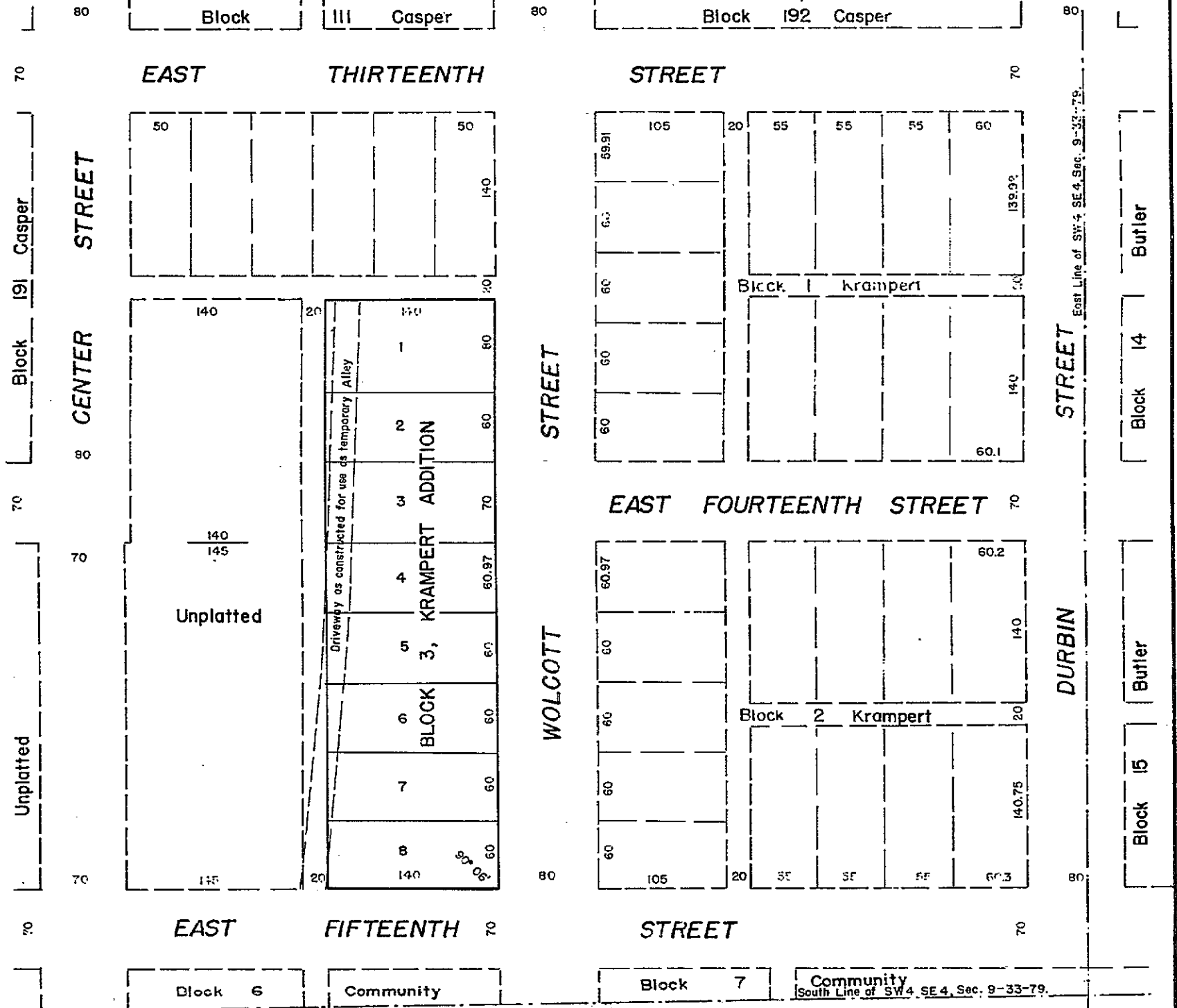

We, E. W. Krampert and Gertrude M. Krampert of Casper, County of Natrona, State of Wyoming, do hereby certify that we are the sole owners of those certain lands shown on this plat and designated as Block 3, Krampert Addition to the City of Casper, County of Natrona, Wyoming, being a part of the Southwest Quarter of the Southeast Quarter of Section Nine, Township 33 North, Range 79 West of the 6th P.M., and situate in the County of Natrona, State of Wyoming; that the subdivision of the land as the same appears on this plat is with our free consent and in accordance with our desires; that Gertrude M. Krampert waives all rights and privileges under all homestead and exemption laws of the State of Wyoming; and that said subdivision shall be known as Block 3 of Krampert Addition to the City of Casper, Wyoming.

I, L. Worthington of Casper, Wyoming, of lawful age and being first duly sworn according to law, as his oath says that he is a Licensed Surveyor in the State of Wyoming, that he made the survey of the land shown on this plat designated as Block 3 of Krampert Addition to the City of Casper, Wyoming, at the request of E. W. Krampert and Gertrude M. 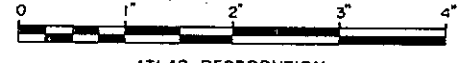
