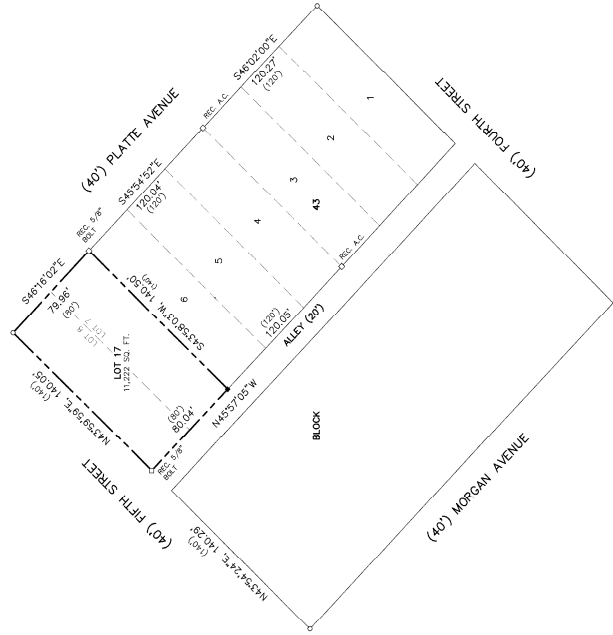
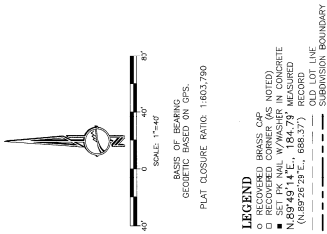

CERTIFICATE OF DEDICATION
