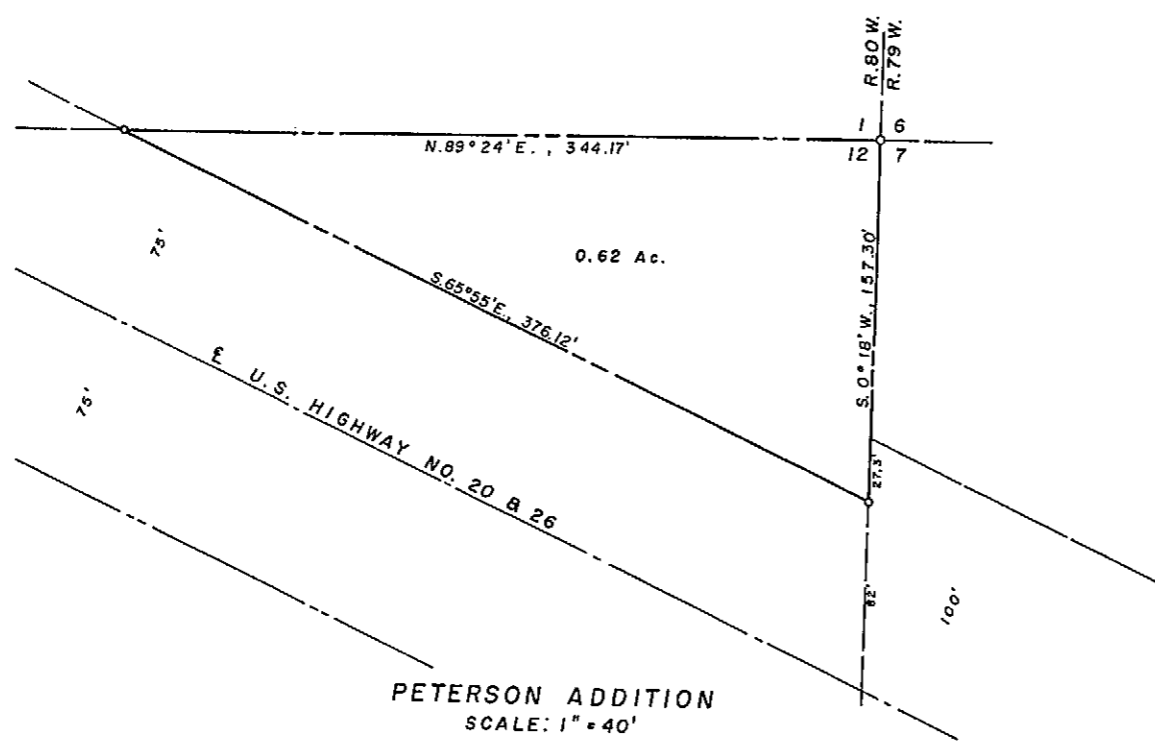
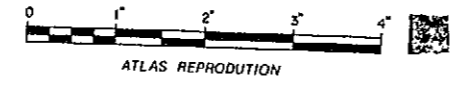


VICINITY MAP

CERTIFICATE OF PLATTING
IN ACCORDANCE WITH ORDINANCE NO. 146 OF THE TOWN OF MILLS
EFFECTIVE AS OF NOVEMBER 2, 1964

The Town of Mills, Natrona County, Wyoming, and the Mayor and Town Council thereof, on the 29th day of October, 1964, received a petition from the owners of the lands of that certain tract hereinafter particularly described as Block 9, Kiskis Subdivision of NE 1/4 NE 1/4 of Section 12, Township 33 North, Range 80 West of the 6th P.M., also described as

A tract of land in the NE 1/4 NE 1/4, Section 12, Township 33 North, Range 80 West of the 6th P.M., containing 0.62 acres, more or less, being more particularly described as follows:

Beginning at the northeast corner of Section 12, Township 33 North, Range 80 West of the 6th P.M.; thence South 89° 24' West, 344.17 feet along the north line of said Section 12 to a point, said point being the intersection of the north boundary of Section 12 and the north boundary of U.S. Highway No. 20 and 26; thence South 65° 55' East, 376.12 feet along the north boundary of said Highway to an intersection with the easterly line of said Section 12; thence along the easterly line of Section 12, North 0° 18' East, 157.30 feet to the point of beginning.

to have the said tract included within the corporate limits of the said Town of Mills, and said Town Council having determined that the owners of all of said tract have petitioned to annex and that no notice and public hearing are required, and the said Town Council having determined that said petition should be granted and that said tract should be included in and become a part of the Town of Mills, Wyoming, to be known and described as "PETERSON ADDITION" to the Town of Mills, Natrona County, Wyoming.
