CERTIFICATE OF DEDICATION

Raymond H. Shellabarger and Mary E. Shellabarger, Husband and Wife, hereby certify that they are the owners and proprietors of the foregoing lands located in and being portions of the NW1/4SW1/4 and NE1/4SW1/4, Section 2, Township 33 North, Range 79 West of the Sixth Principal Meridian, Natrona County, Wyoming and being more particularly described as follows:

Commencing at the northeasterly corner of said NW1/4SW1/4, Section 2; thence into said NW1/4SW1/4, Section 2, S.12°10'31"W., 441.58 feet to a point in the south-westerly right-of-way line of U.S. Interstate Highway No. 1-25 and also the northwesterly corner of the Parcel being described and the true Point of Beginning; thence from said Point of Beginning and along the northeasterly line of said Parcel and southwesterly right-of-way line of said Highway, S.59°17'06"E., 377.71 feet to the northeasterly corner of said Parcel; thence along the easterly line of said Parcel, S.25°34'10"W., 162.32 feet to the southeasterly corner of said Parcel and a point in the north-erly right-of-way line of Yellowstone Highway (U.S. Highway No. 20-26); thence along the southerly line of said Parcel and the northerly right-of-way line of said Yellowstone Highway, S.78°13'40"W., 339.25 feet to the southwesterly corner of said Parcel and a point on a circular curve concave westerly; thence along the westerly line of said Parcel and along the arc of a true curve to the left, having a radius of 218.16 feet and through a central angle of 140°18', northerly, 534.27 feet to the Point of Beginning and containing 1.20 acres, more or less.

The subdivision of the foregoing described lands as appears on this plat is with the free consent and in accordance with the desires of the above named owners and prop-rietors; the name of said subdivision shall be known as "SHELLABARGER ADDITION" to the City of Casper, Wyoming. The 20 feet wide storm sewer as shown hereon has previously been reserved and all highways as shown hereon have been previously dedicated to public use.

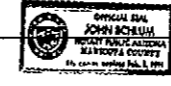

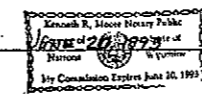

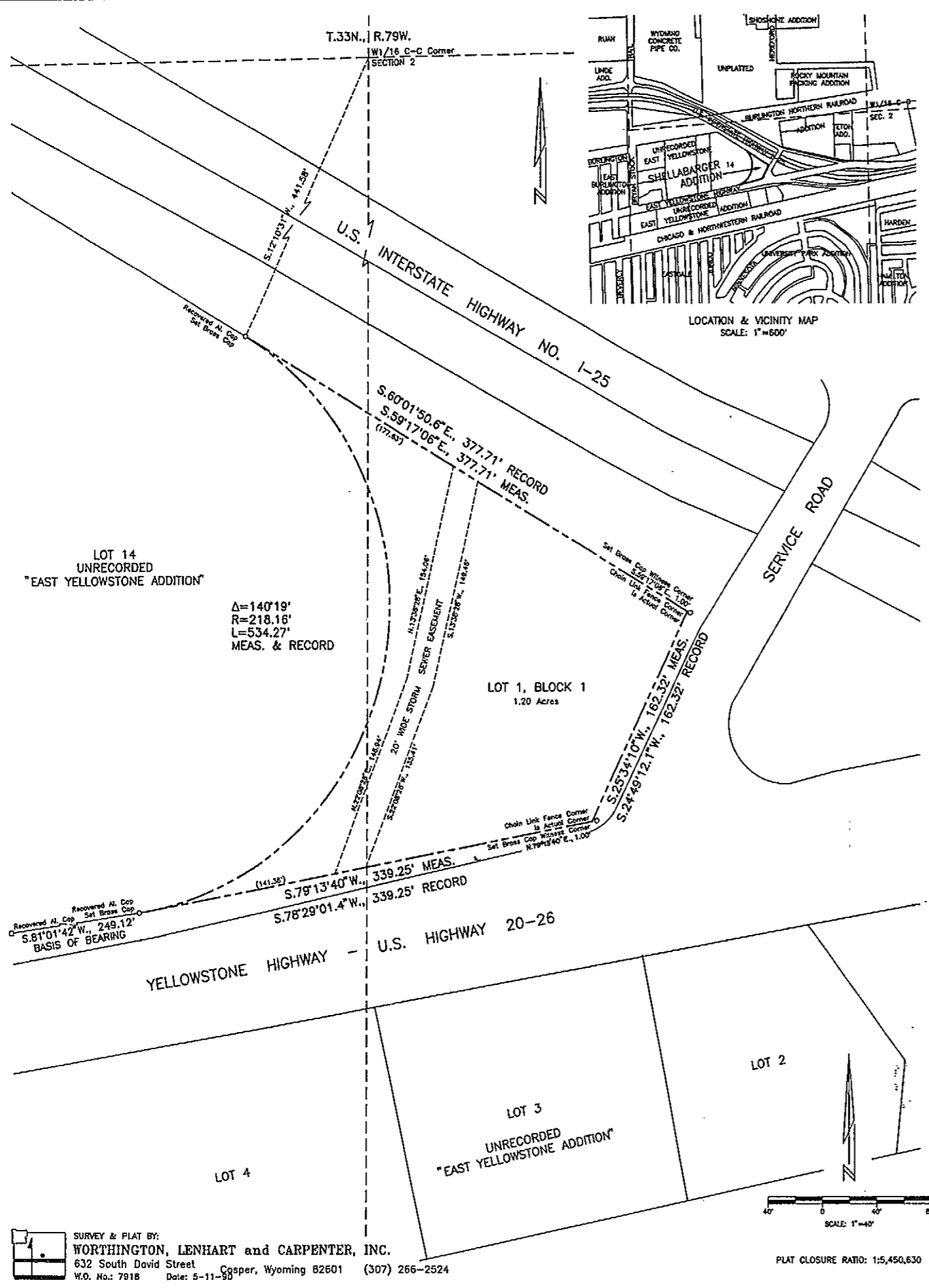
