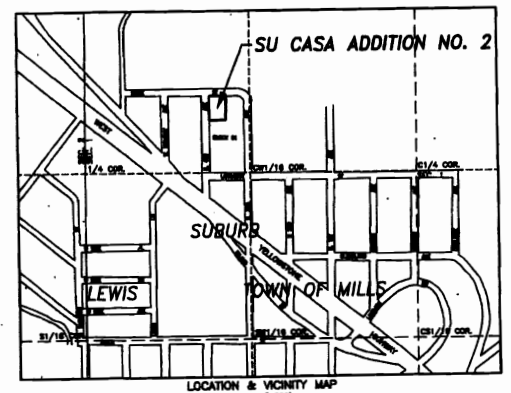
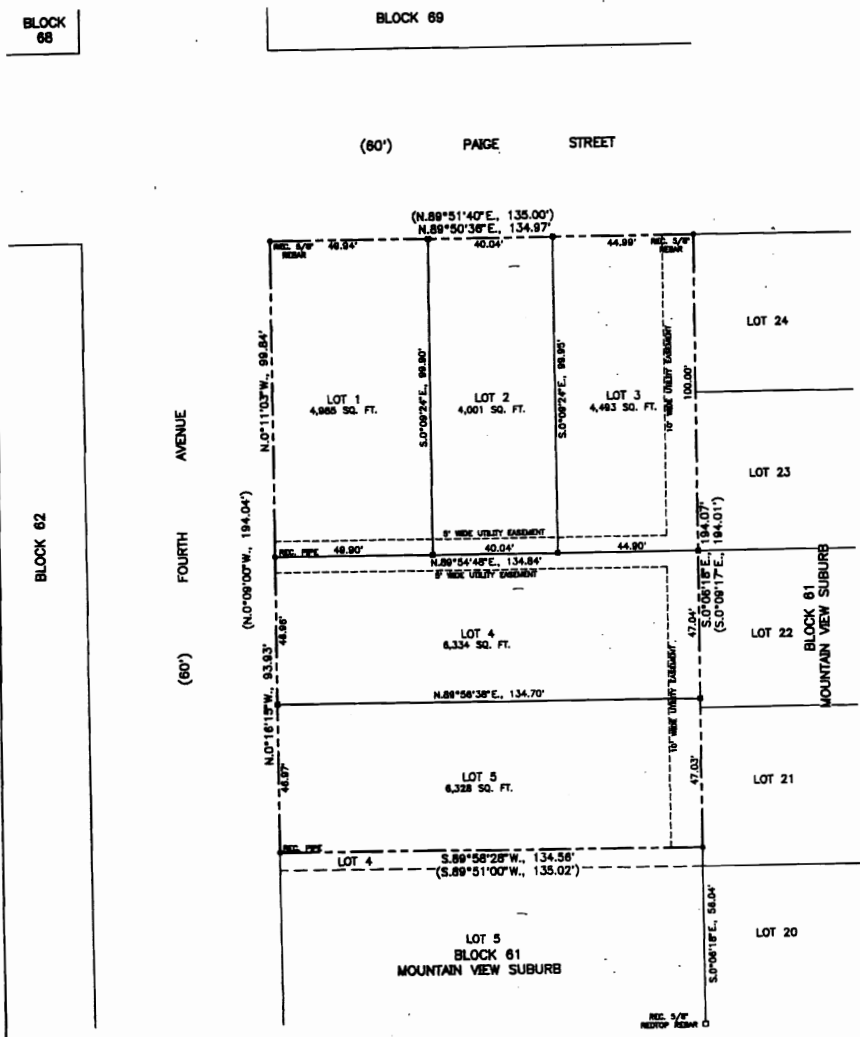

**CERTIFICATE OF DEDICATION**

Emmylyn Page - Wolcott hereby certifies that she is the owner and proprietor of the foregoing vacation and replat of Su Casa Mobile Home Park, Town of Mills, Wyoming, a subdivision of a portion of the S1/2NW1/4, Section 1, Township 33 North, Range 80 West of the Sixth Principal Meridian, Natrona County, Wyoming and being more particularly described by metes and bounds as follows:

Beginning at the northwesterly corner of the Parcel being described and also the northwesterly corner of said Su Casa Mobile Home Park and a point of intersection of the easterly line of Fourth Avenue with the southerly line of Paige Street; thence along the northerly line of said Parcel and Su Casa Mobile Home Park and the southerly line of said Paige Street, N.89°50'38"E., 134.97 feet to the northeasterly corner of said Parcel and Su Casa Mobile Home Park and the northwesterly corner of Lot 24, Block 61, Mountain View Suburb; thence along the Park and the northwesterly corner of Lot 24, Block 61, Mountain View Suburb, thence along the easterly line of said Parcel and Su Casa Mobile Home Park and the westerly line of Lots 24, 23, 22, and 21, Block 61, Mountain View Suburb, S.0°08'18"E., 184.07 feet to the southwesterly corner of said Parcel and Su Casa Mobile Home Park; thence along the westerly line of said Parcel and Su Casa Mobile Home Park and across Lot 4, Block 61, Mountain View Suburb, S.89°58'28"W., 134.56 feet to the southwesterly corner of said Parcel and Su Casa Mobile Home Park and a point in and intersection with the easterly line of said Fourth Avenue; thence along the westerly line of said Parcel and Su Casa Mobile Home Park and the easterly line of said Fourth Avenue, N.0°18'18"W., 83.93 feet to a point; thence continuing along the westerly line of said Parcel and Su Casa Mobile Home Park and the easterly line of said Fourth Avenue, N.0°11'03"W., 99.64 feet to the Point of Beginning and containing 0.800 acres, more or less.

The vacation and replat of the foregoing described lands as appears on this plat is with the free consent and in accordance with the desire of the above named owner and proprietor of said lands; the name of said vacation and replat shall be known as "SU CASA ADDITION NO. 2" to the Town of Mills, Wyoming. All streets as shown hereon have previously been dedicated to the use of the public.
