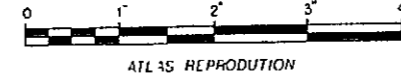


# SUNNYSIDE ACRES

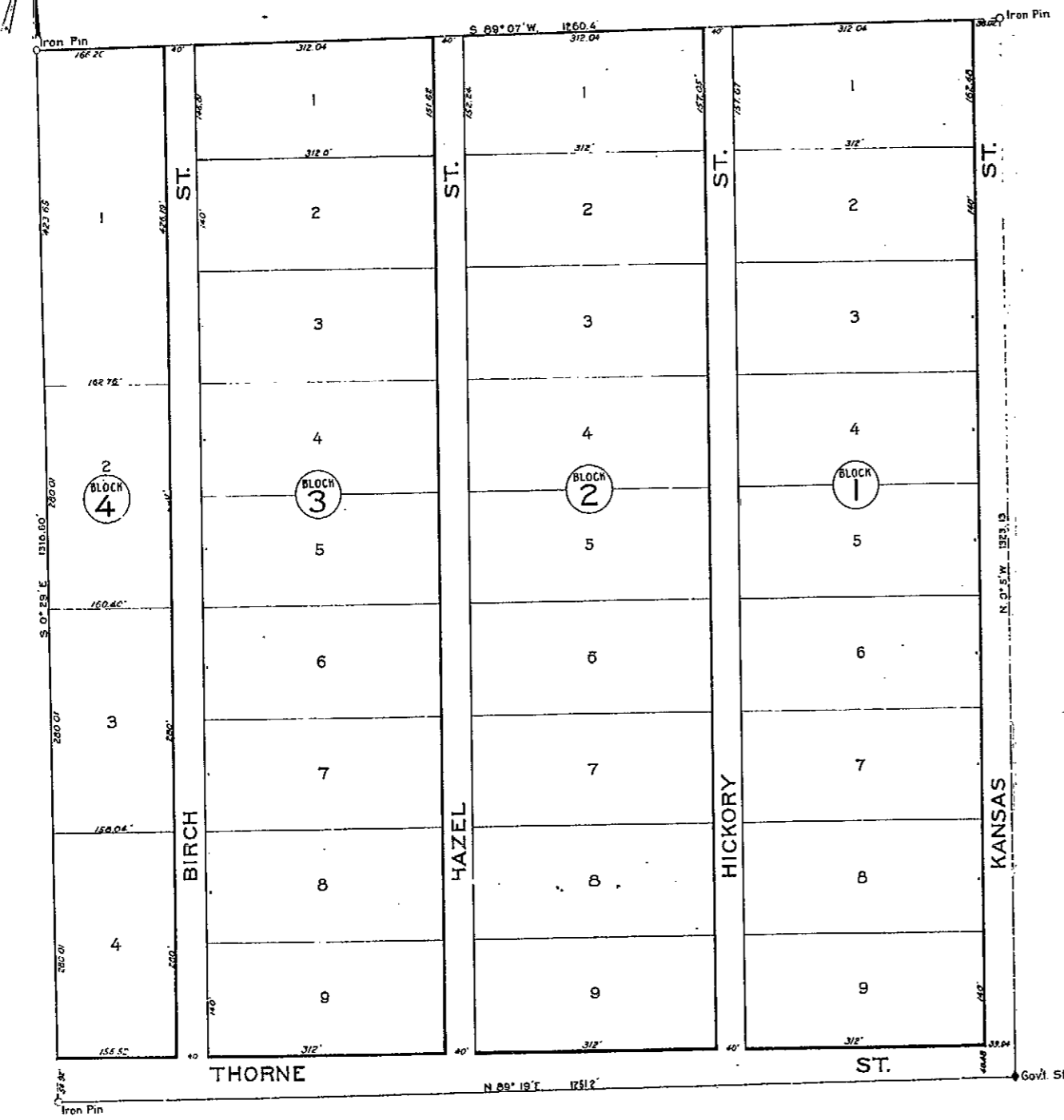
## NATRONA COUNTY WYO
