SCALE 1 INCH = 120 FEET

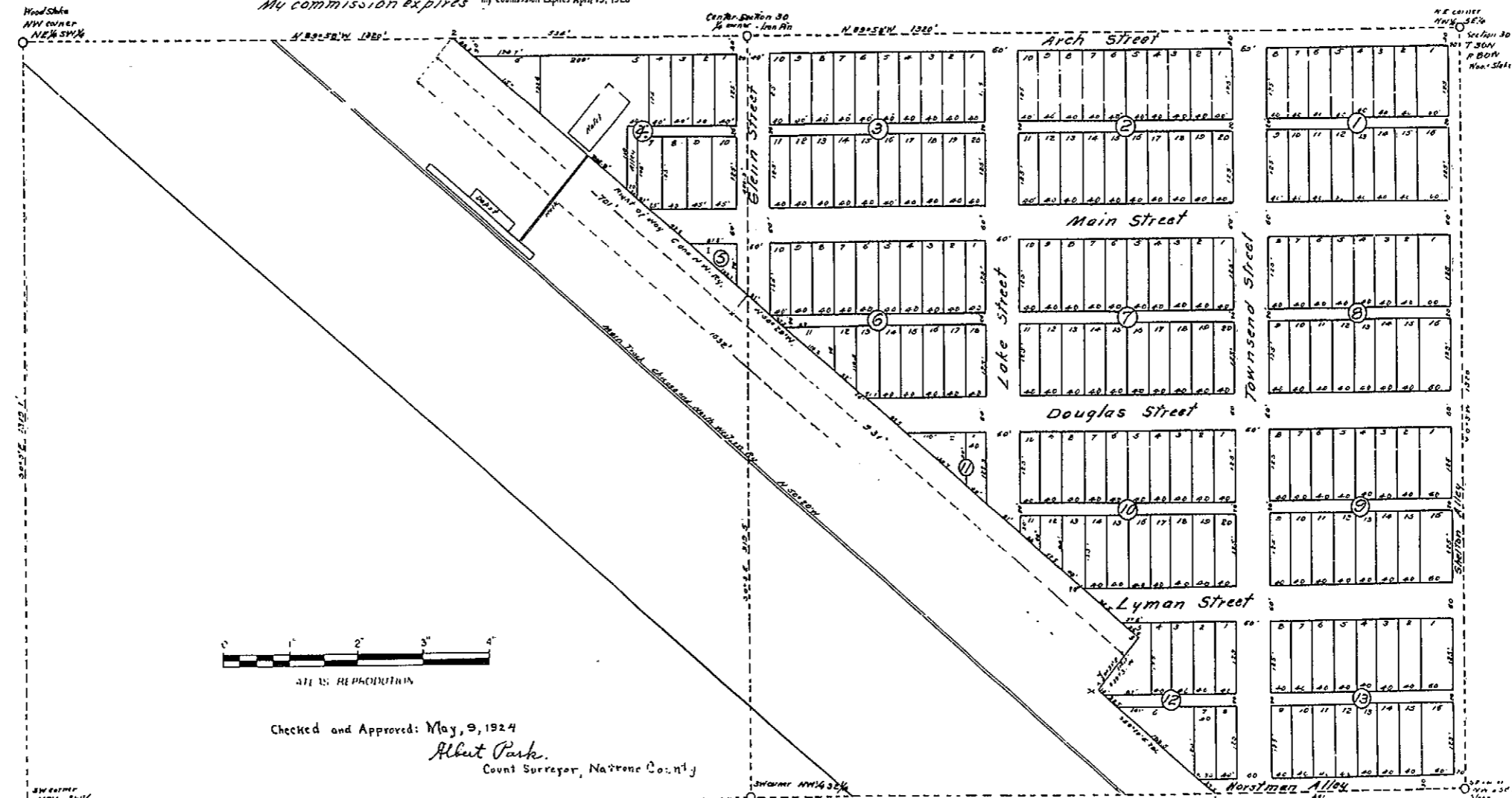
