CERTIFICATE OF DEDICATION

The undersigned Harvey A. Daigle and Delphine M. Daigle, husband and wife and Don Coffman and Charlene Coffman, husband and wife, the owners of the foregoing subdivision of a part of the SE 1/4 NE 1/4, Section 2, Township 33 North, Range 79 West of the 6th Principal Meridian, Natrona County, Wyoming, as set forth by and as appears on this plat and more particularly described by metes and bounds as follows:

Commencing at the southeast corner of said SE 1/4 NE 1/4, Section 2, thence along the easterly line thereof, N 0° 02' W., 360.85 feet to a point in the northerly right of way line of the Burlington-Northern, Inc. Railway Company (formerly Chicago, Burlington and Quincy Railway Company); said point also marks the southeast corner of said Parcel and "WESTERN ADDITION" to the Town of Evansville;

Thence from the last described point and corner, N 0° 02' W., 967.35 feet along the easterly line of said SE 1/4 NE 1/4, Section 2 to the northeast corner thereof and also said Addition; thence along the northerly line of said SE 1/4 NE 1/4, Section 2 and said Addition, S 87° 48' W., 438.65' to a point and northwest corner of said Addition; thence along the westerly line of said Parcel and Addition and parallel to the easterly line thereof, S 0° 02' E., 1003.58 feet to a point in the northerly right of way line of said Railway Company and the southwest corner of said Parcel and Addition; thence along said right of way line and the southerly line of said Parcel and Addition, N 83° 07' E., 441.50 feet to the southeasterly corner thereof and point of beginning and containing 9.915 acres, more or less;

The name of said subdivision shall be "WESTERN ADDITION" to the Town of Evansville, Wyoming and all streets and/or public ways as set forth by this platting are hereby dedicated to the use of the public. 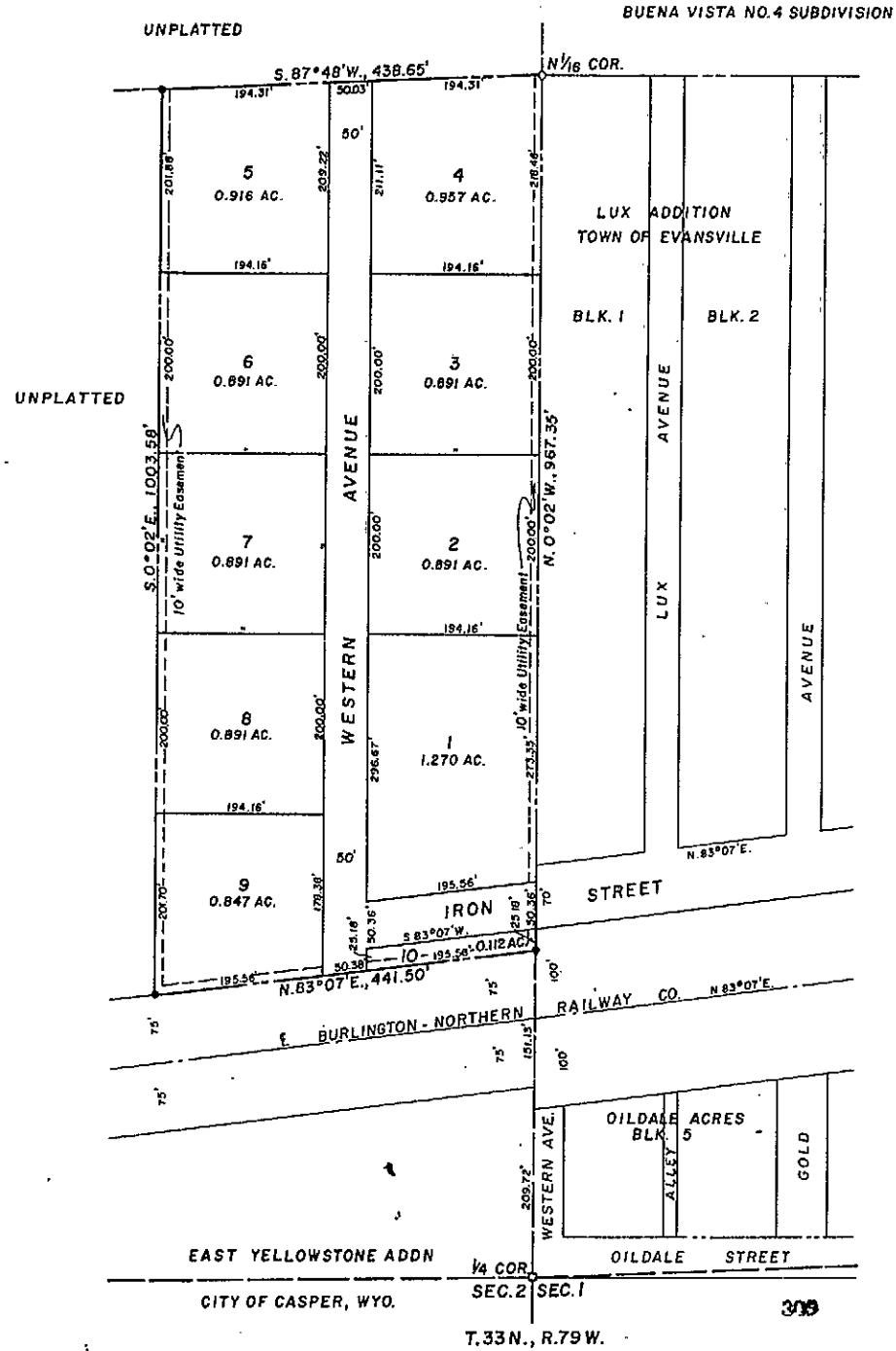
