Natrona County School District No. 2, State of Wyoming, a Body Corporate in the County of Natrona, State of Wyoming does hereby certify that the foregoing part of SW 1/4 NW 1/4, Section 12, Township 33 North, Range 79 West of the 6th Principal Meridian, Natrona County, Wyoming as shown on this plat is with the consent and in accordance with the desires of the undersigned owners and proprietors of said lands that said part of the SW 1/4 NW 1/4, Section 12, shall be named and designated as "WOODS SCHOOL ADDITION" to the City of Casper, Natrona County, Wyoming, that the streets and public ways shown on this plat be dedicated to the use of public. A metes and bounds description of said Addition is as follows:

Beginning at the NW corner of Sections 11 and 12 of said T. 33 N., R. 79 W., 6th Principal Meridian and the northwest corner of the parcel being described, thence N89°57'E., 466.70 feet to the northeast corner of said parcel, thence S0°10'E., 466.70 feet to the southeast corner of said parcel, thence S89°57'W., 466.70 feet to the southeast corner of said parcel and a point in the line common to said Sections 11 and 12, thence N 0°10' W., along said line common to Sections 11 and 12, 466.70 feet to said northeast corner and the point of beginning, containing 5.00 acres, more or less.
