Beginning at the northwesterly corner of the Parcel being described and also a point in the northerly line of said NW1/4NW1/4, Section 7 and from which point the northwesterly corner of said NW1/4NW1/4, Section 7 bears S89°23'13"W, 100.00 feet; thence along the northerly line of the Town of Mills, Wyoming, N89°23'13"E, 451.31 feet to the southerly line of said Parcel; thence along the westerly line of said Parcel and a point in and intersection with the northerly right-of-way line of U.S. Highway Nos. 20 & 28; thence along the southerly line of said Parcel and the northerly right-of-way line of said Highway, N65°51'17"W, 218.02 feet to a point; thence S0°33'35"W, 21.30 feet to a point; thence along the westerly line of said Parcel and the southerly line of said Peaches Addition, N24°05'16"E, 170.00 feet to the southerly line of said Parcel; thence along the southerly line of said Parcel, N65°51'17"W, 170.70 feet to the southerly corner of said Parcel and a point in and intersection with the easterly line of Hudson Street; thence along the easterly line of said Parcel and the easterly line of said Hudson Street, N10°28'17"E, 53.49 feet to the Point of Beginning and containing 3.508 acres, more or less.

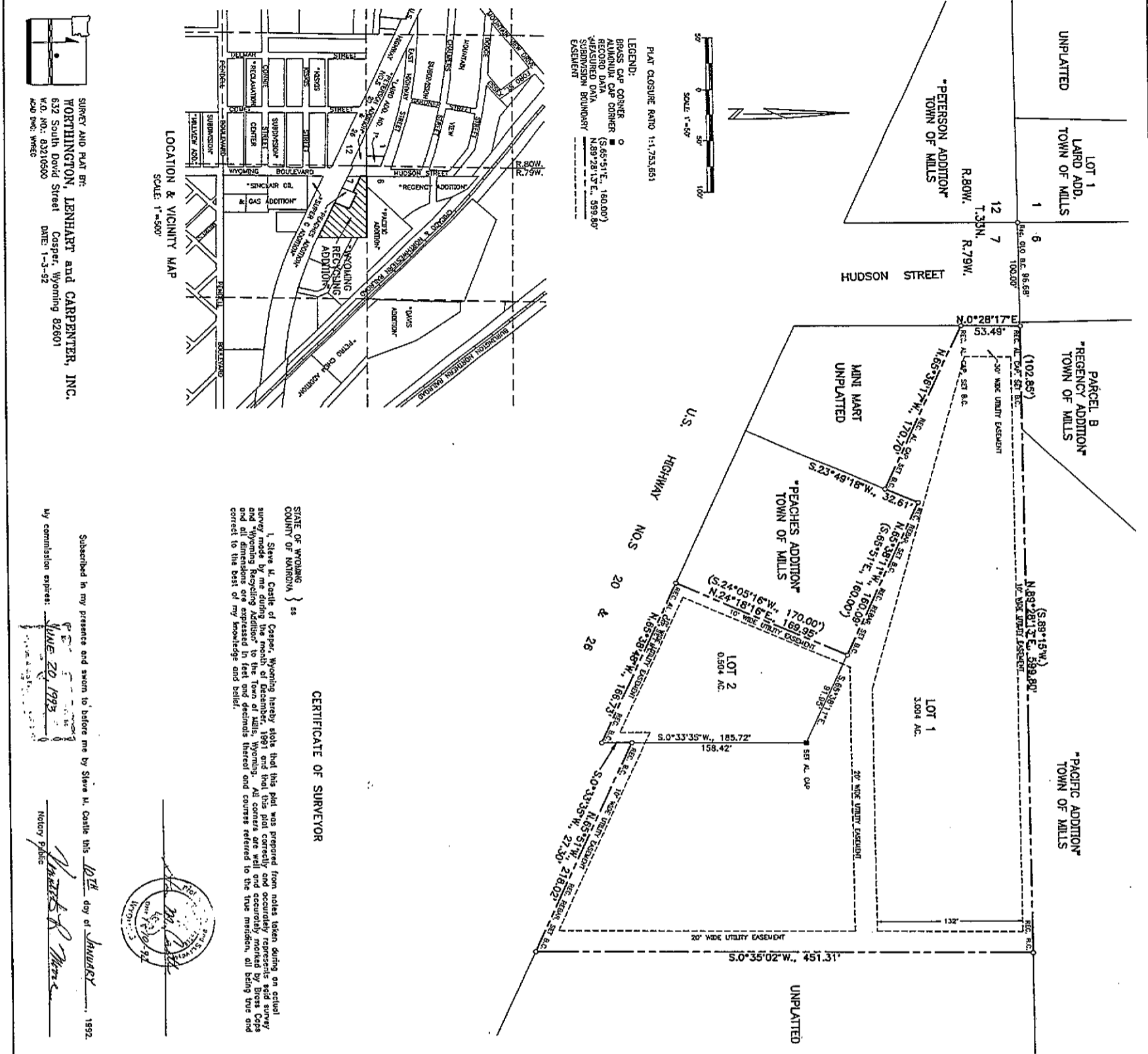
