CERTIFICATE OF DEDICATION

I, Lee Graham of Cody, Wyoming, hereby certify that during the period from August 1, 1967 to August 22, 1967, the North Cedar Ridge Addition was surveyed by me and under my direction, that said subdivision is correctly described in the Owner's Certificate of Dedication on this plat which is drawn to a scale of 1"=100'. The widths of streets and alleys and the dimensions of lots as given in feet and decimals of feet and any surplus or deficiency is distributed uniformly in proportion to the measurements shown on this plat. Each block and lot bears its own number. All lot corners are 1" x 16" pipe driven firmly into the ground.




