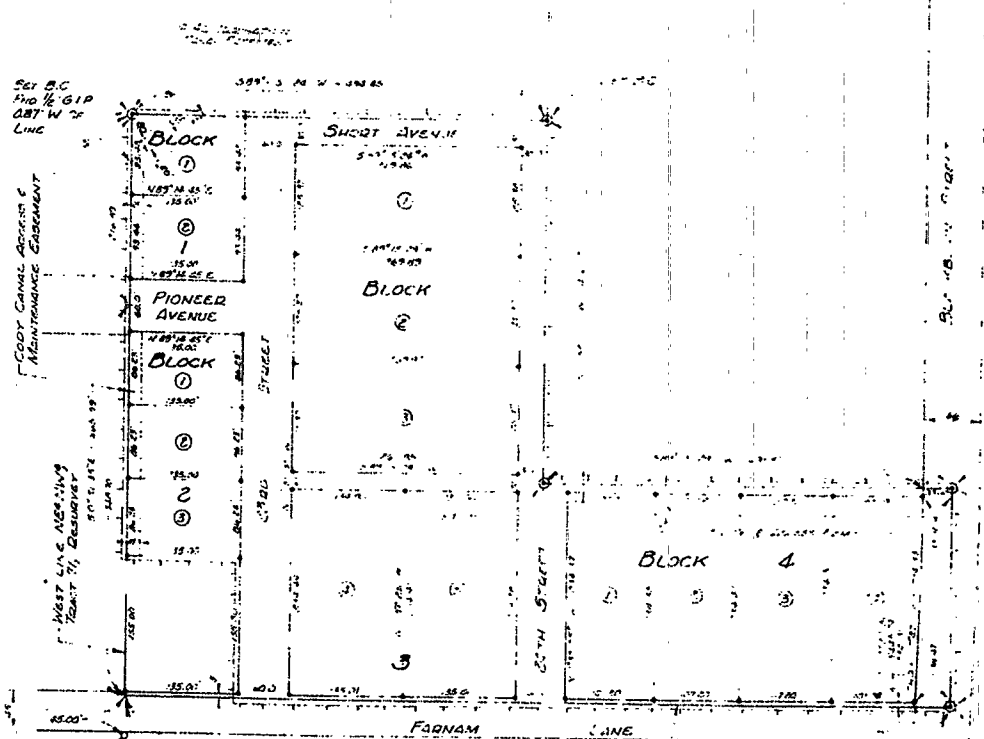


LOCATION MAP

I, J HARVEY COPELAND, OF COOY, WYOMING, HEREBY CERTIFY THAT DURING THE PERIOD FROM 29 MARCH 1980 TO 9 JUNE 1980, THE DOUBLE "M" ADDITION TO THE CITY OF COOY WAS SURVEYED BY ME; THAT SAID ADDITION IS CORRECTLY DESCRIBED IN THE CERTIFICATE OF DEDICATION ON THIS PLAT WHICH IS DRAWN TO A SCALE OF 1" = 100'. THE WIDTH OF THE STREETS AND ALLEYS AND THE DIMENSIONS OF THE LOTS ARE GIVEN IN FEET AND DECIMALS OF A FOOT, AND ANY SURPLUS OR DEFICIENCY IS DISTRIBUTED UNIFORMLY IN PROPORTION TO THE MEASUREMENTS SHOWN ON THIS PLAT. EACH BLOCK AND LOT BEARS ITS OWN NUMBER.
