### Certificate of Dedication.

This certifies that Lucylle M. Hall, is the owner of the parcel of land shown on this plat as the amended plat of Lowry's Small Farms and the Hall Addition near the City of Cody, Wyoming, and henceforth to be known only as the Hall Addition near the City of Cody, Wyoming, which may be described as a part of the Northwest Quarter of the Northwest Quarter (NW 1/4 NW 1/4) of Tract 71, (formerly Section 33), Township 53 North, Range 101 West of the 6th Principal Meridian, in Park County Wyoming more particularly described as follows:

Beginning at a point on the west boundary of Tract 71, which is 849 ft. south-erly from Corner No. 1 of Tract 71, thence North 89°49' East for 207.25 ft., thence North 0°15' West for 250 ft., thence North 89°49' East for 1112.75 ft., thence South 0°15' East for 731.7 ft., thence South 89°49' West for 668.3 ft., thence North 0°15' West for 208.7 ft., thence South 89°49' West for 208.7 ft., thence South 0°15' East for 208.7 ft., thence South 89°49' West for 443.0 ft., thence North 0°15' West for 481.7 ft., to the point of beginning; said parcel of land to include 19.973 acres more or less; that the owner has caused said parcel of land to be surveyed and platted as the Hall Addition near the City of Cody, Wyoming, that the streets, avenues and alleys as shown are hereby dedicated to the public use and subject to rights of way for legal highways and irrigation laterals, and further that the details as appear on this plat are with the free consent and in accordance with the wishes of the undersigned owner and proprietor.
