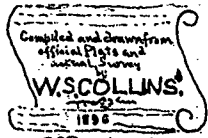


Map of MEETEETSE

This map entitled Map of Meeteetse in Fremont County, Wyoming, represents a subdivision of part of the southeast quarter of the northwest quarter, and of the north and east quarters of the southwest quarter and part of the northwest quarter of the southwest quarter of Section Four, Township Forty-eight North, of Range One hundred West, and contains 36.6 acres.

Dutton, Franklin, State, Warren and South streets each 60 feet wide.

Water, Park, Mondell and Highland avenues each 60 feet wide.

The location, names, numbers and dimensions of the streets, blocks and lots in the said subdivision are marked, described and shown on and by the accompanying plat.

The said subdivision has been accurately surveyed and plotted in the month of January 1896.

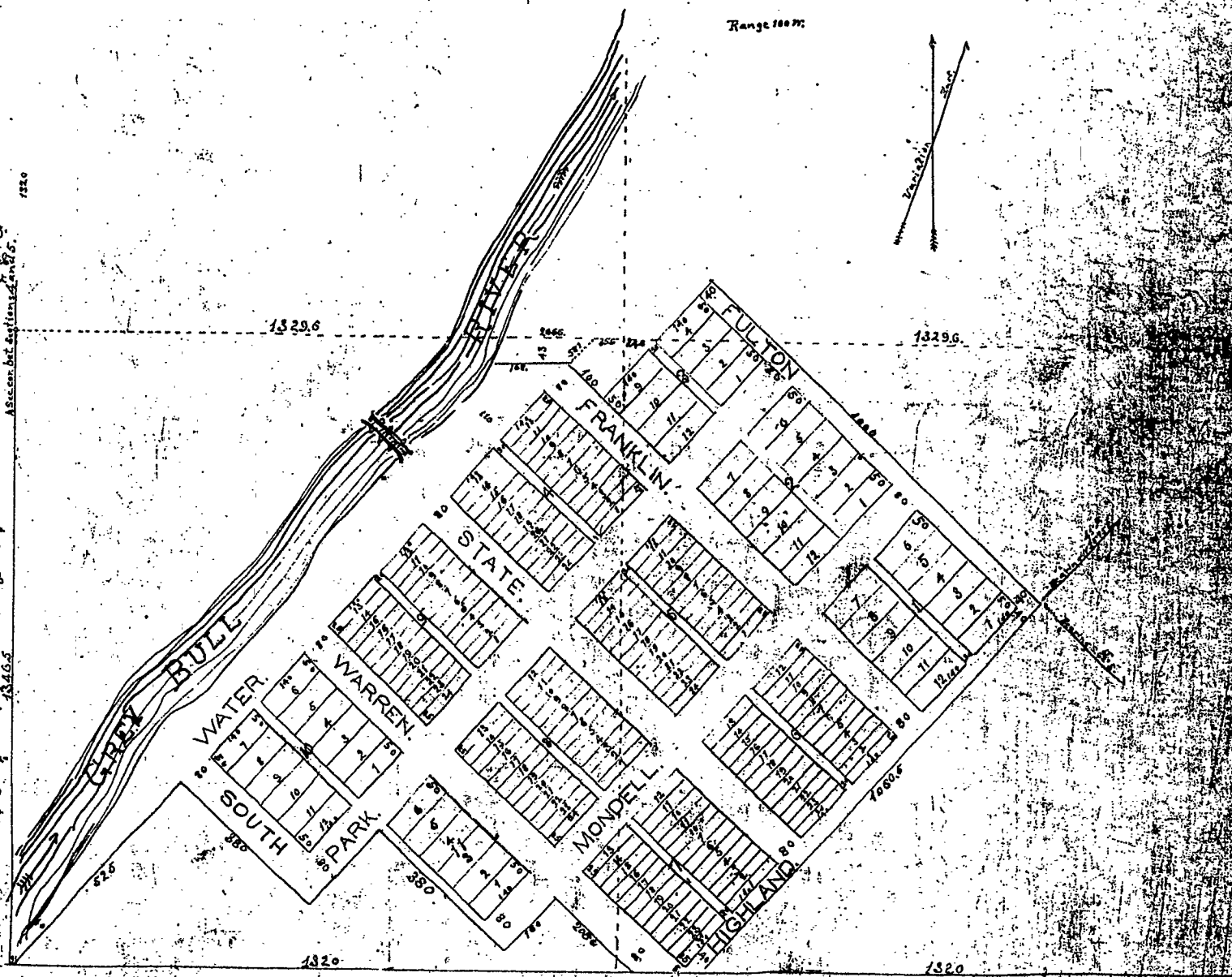

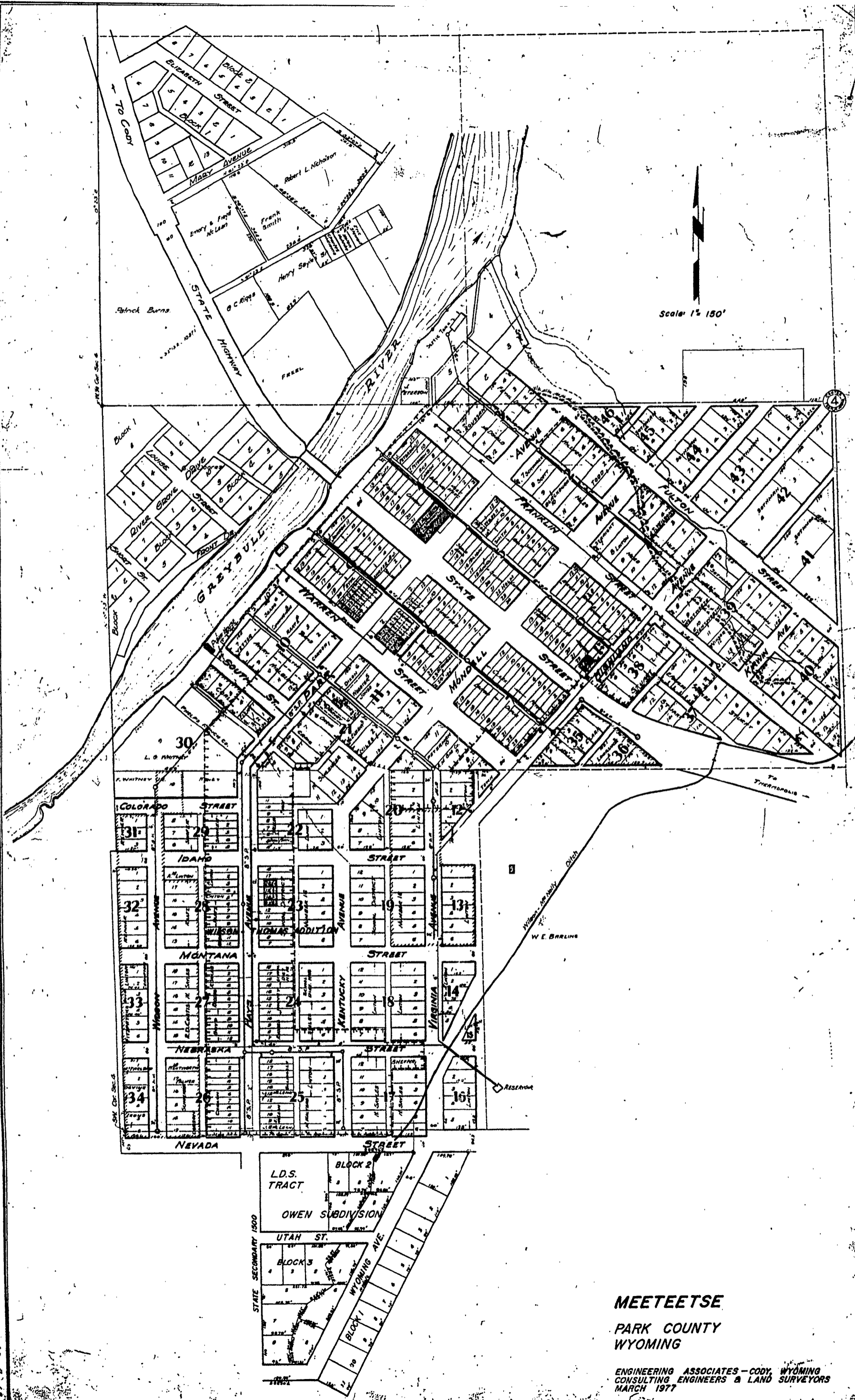

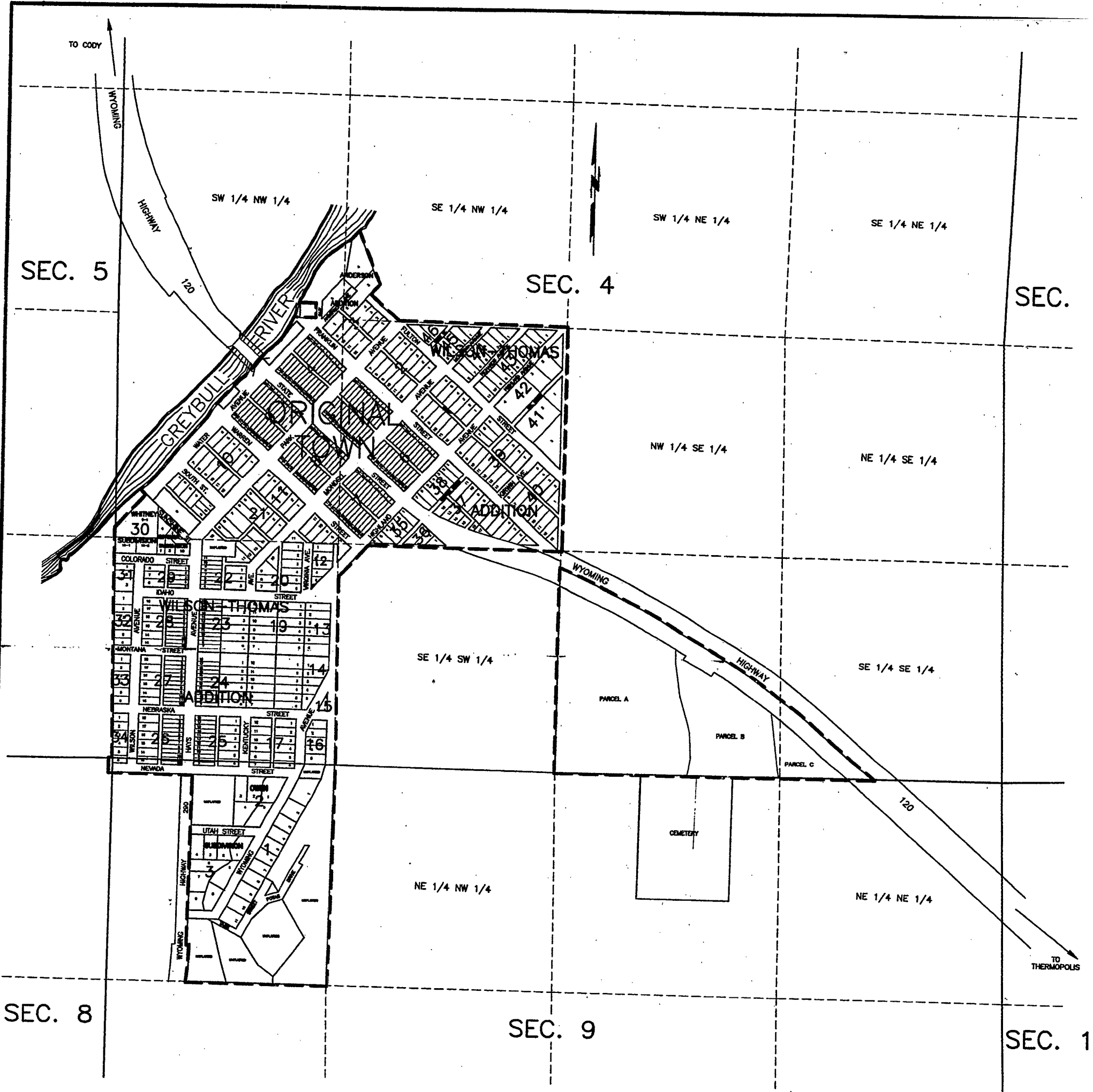
