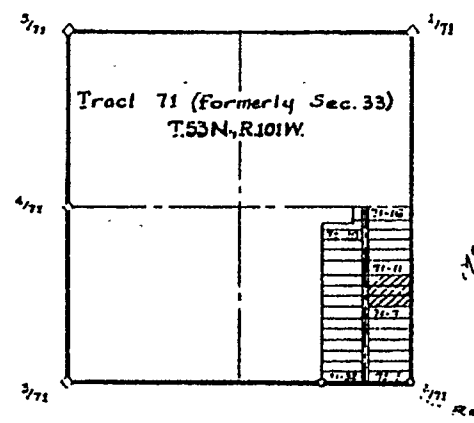


Detail Map.
