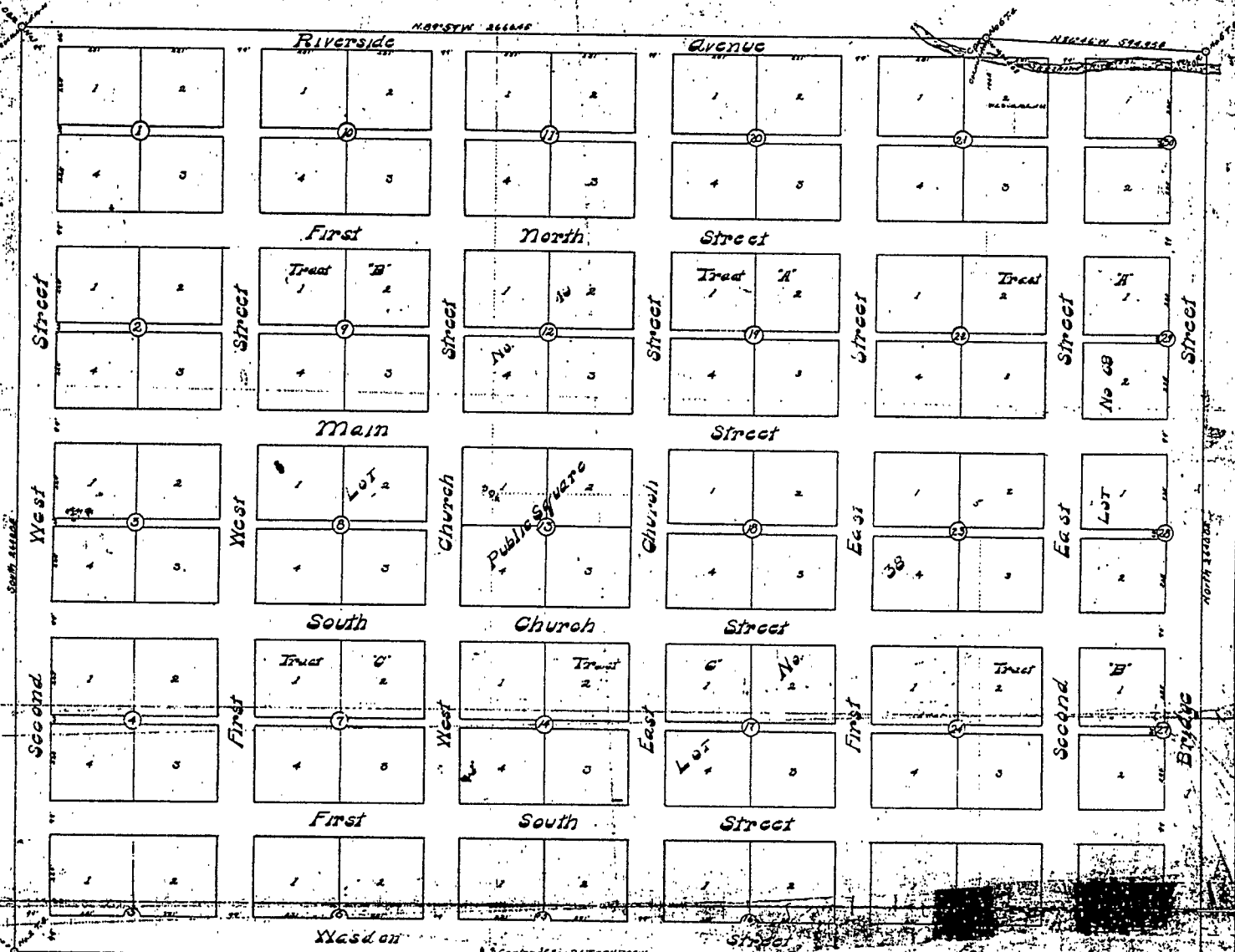


TOWN OF PENROSE PARK CO. WYOMING

I hereby certify that on the 27th day of April, A.D. 1917, I surveyed the Town of Penrose, situated on lands in Section 24, Township 24 North, Range 90 West, 6th P.M., as is shown by the annexed plat, which is a correct delineation of said survey, drawn to a scale of 1 inch to 200 feet. The Streets and Allys are laid out parallel with, and right angles to the West Line of Lot No. 46. The corners are marked by stakes set in the ground. The width of the Streets and Allys, and the dimensions of Lots are indicated in feet and decimals on the plat. Each Lot and Block bears its own number.
