



### Certificate of Dedication.

This certifies that George C. Doeres and Jessie F. Doeres are the owners of a parcel of land shown on this plat as the "River Grove Subdivision near Meeteetse, Wyoming", which is described as a part of the Northwest Quarter of the Southwest Quarter, (NW 1/4 SW 1/4) of Section 4, Township 48 North, Range 100 West of the 6th Principal Meridian in Park County, Wyoming, more particularly described as follows:

Beginning at the West 1/4 Corner of Section 4, Township 48 North, Range 100 West of the 6th R.M. in Wyoming, thence North 90°00' East for 369 ft. to the center line of the State Highway near Meeteetse, Wyoming, thence along the center line of said highway to the center line of the Greybull River, thence southwesterly along the center line of the Greybull River to a point on the west boundary of said NW 1/4 SW 1/4 of Section 4, which point is 1086.2 ft. southerly from the West Quarter Corner of Section 4, thence North 0°23' West for 1086.2 ft. along the west boundary of Section 4, to the point of beginning; said parcel of land to contain 10.806 acres, more or less; that the owners have caused said parcel of land to be surveyed and plotted as the "River Grove Subdivision near Meeteetse, Wyoming", that the streets and avenues as shown, are hereby dedicated to public use and subject to legal highways and rights of way for irrigation laterals; and further that the details as appear on this plat are with the free consent and in accordance with the wishes and desires of the undersigned owners and proprietors.
