



CERTIFICATE OF DEDICATION

This certifies that Florence J. Stratton and Herbert E. Stratton of Painter, Wyoming are the owners of the tract of land which is shown on this plat as the "Stratton Subdivision in H.E.S. 177, Township 56 North, Range 106 West of the Sixth P.M. Wyoming" and the boundaries of which are more particularly described as follows: Beginning at Corner N^o 9 of H.E.S. 177 Township 56 North, Range 106 West of the Sixth P.M. Wyoming, which is identical with the closing corner which marks the intersection of the West line of Section 4 of said Township with the boundary of H.E.S. 177; thence N. 40°-18' W. along Line 9-10, of H.E.S. 177, a distance of 1205.5 feet to Corner N^o 10, of H.E.S. 177; thence N. 53°-48' E. along Line 10-11 a distance of 314.7 feet to Corner N^o 11 of H.E.S. 177; thence S 41°-59' E along Line 11-12 a distance of 455.5 feet to Corner N^o 12 of H.E.S. 177; thence S. 68°-04' E. along Line 12-1 a distance of 134.3 feet; thence S 7°-40' E a distance of 725.1 feet to Corner N^o 9, of H.E.S. 177, the point of beginning; subject to any legally established roads or other rights of way legally acquired; that the owners have caused said tract of land to be surveyed and platted as the "Stratton Subdivision in H.E.S. 177, Township 56 North, Range 106 West of the Sixth P.M.
