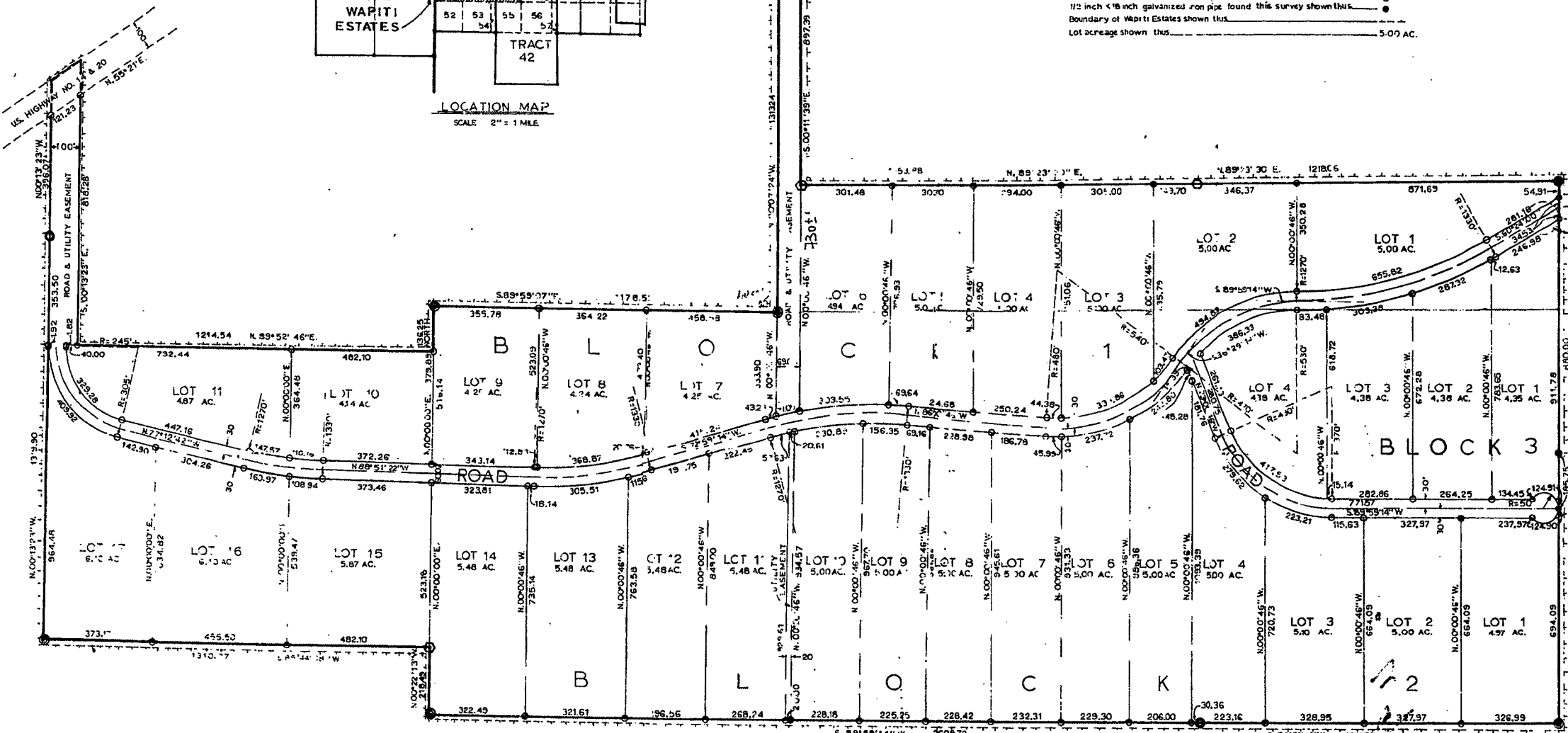


LOCATION MAP
