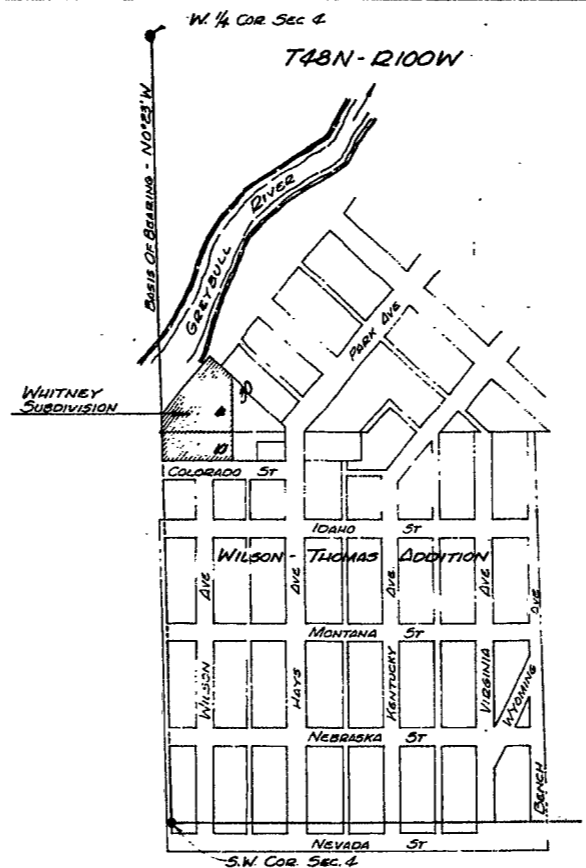
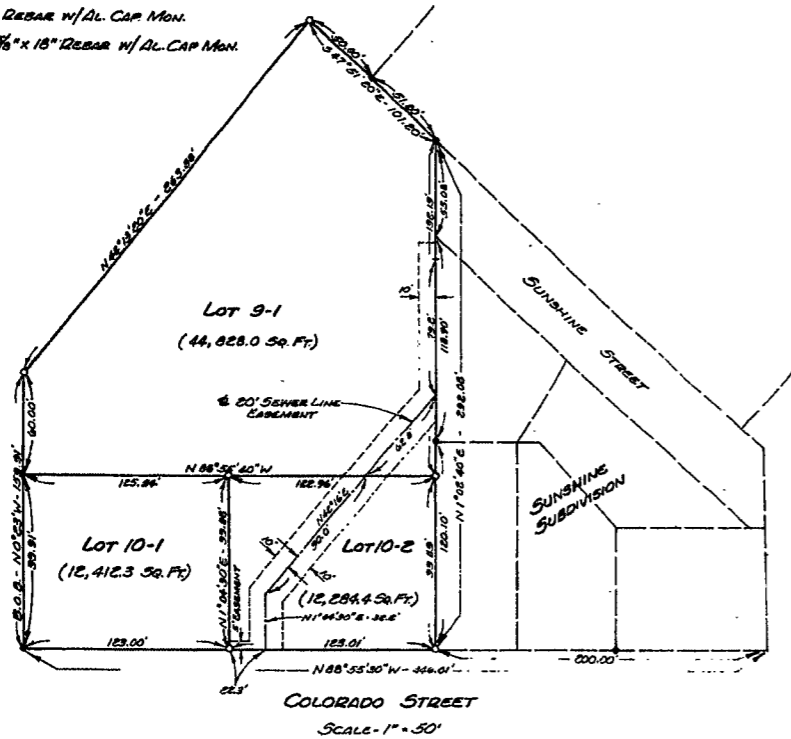


- FND. REBAR W/AL. CAP. MON.

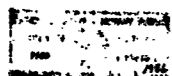
