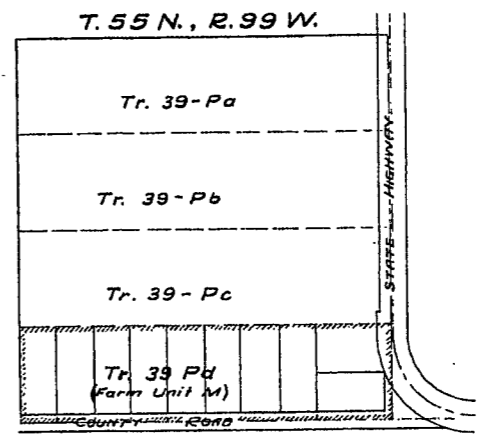

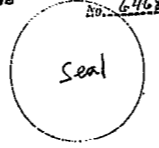

CERTIFICATE OF SURVEYOR

I, Howard F. Bell, of Cody, Wyoming, hereby certify that during the month of June, 1948, "Willwood Subdivision" in Lot 39-Pd Township 55 North, Range 99 West of the Sixth P.M. Wyoming, also known as Farm Unit "M", Lot 39, according to the Farm Unit Plat of said Township and Range, was surveyed by me; that said subdivision is described on this plat in the Owners Certificate of Dedication and that the same is correctly shown on this plat which is drawn to a scale of one inch equals one hundred feet.
